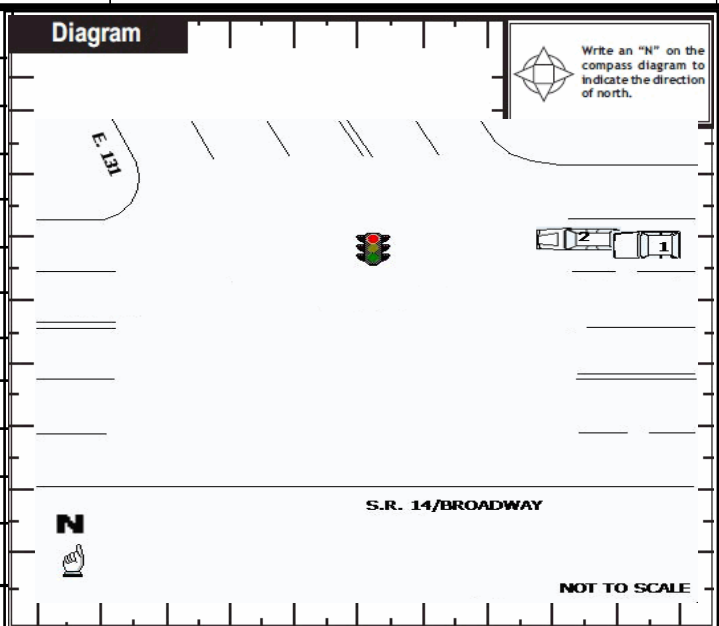




Narrative

UNIT #1 AND UNIT #2 WERE BOTH TRAVELING W/B ON BROADWAY AVENUE IN THE OUTSIDE LANE. WHILE UNIT #2 SLOWED TO TURN N/B ONTO E. 131ST STREET, UNIT #1 DID NOT MAINTAIN AN ASSURED AND CLEAR DISTANCE AHEAD, CAUSING THE FRONT-END OF UNIT #1 TO COME IN CONTACT WITH THE REAR OF UNIT #2.
