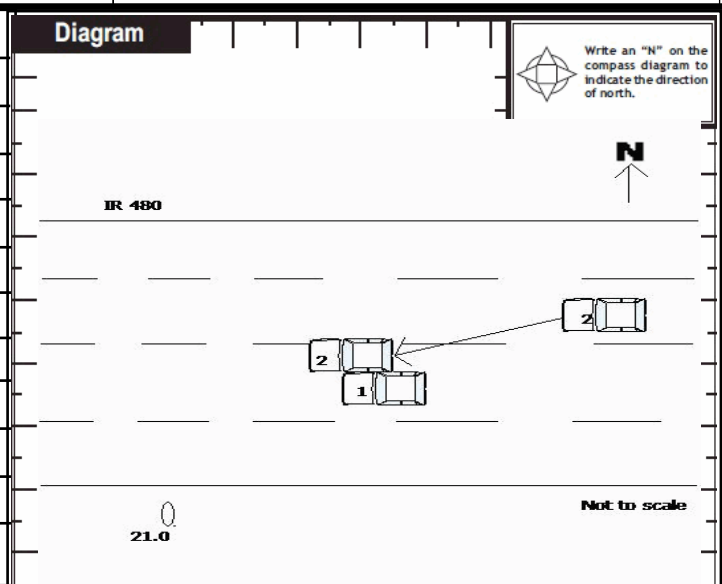

UNIT 1 WAS TRAVELING WEST ON IR-480 IN THE RIGHT LANE APPROACHING TRANSPORTATION BLVD. UNIT 2 WAS ENTERING IR-480 WEST FROM TRANSPORTATION AND MERGED ON IN FRONT OF UNIT 1. UNIT 1 THEN MADE A LANE CHANGE IN TO THE NEXT LANE SOUTH OF HIM AND UNIT 2 ALSO MADE THE SAME LANE CHANGE. UNIT 1 THEN CHANGED LANES ONCE MORE IN TO THE LANE SOUTH OF HIM AND ACCELERATED. UNIT 2 THEN ATTEMPTED TO CHANGE INTO UNIT 1'S LANE AND STRUCK UNIT 1 AS IT WAS PASSING.


