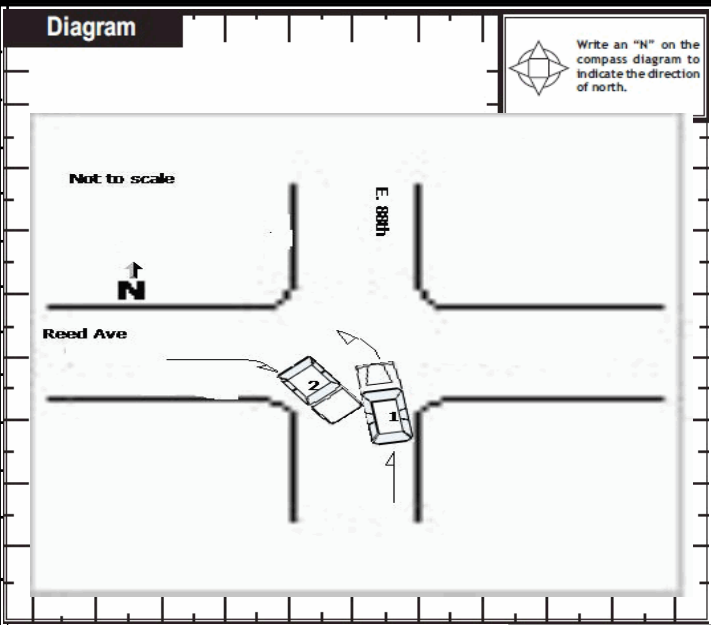




UNIT 1 STATES SHE WAS TRAVELING N/B ON E. 88TH. UNIT 1 CAME TO A STOP AT THE INTERSECTION OF E.88TH/ REED AVE. UNIT 1 OBSERVED UNIT 2, ON REED AVE E/B, COME TO A STOP AT THE INTERSECTION. UNIT 1 PROCEEDED TO TURN LEFT (W/B) ONTO REED. UNIT 1 STATES SHE DID NOT OBSERVE UNIT 2 AS THE TWO UNITS MADE IMPACT. UNIT 2 STATES SHE WAS STOPPED AT THE INTERSECTION (REED E/B @ E. 88TH) WHEN UNIT 1 BEGAN TO TURN LEFT, STRIKING UNIT 2. FAULT FOR THE ACCIDENT WAS NOT ABLE TO BE DETERMINED.
