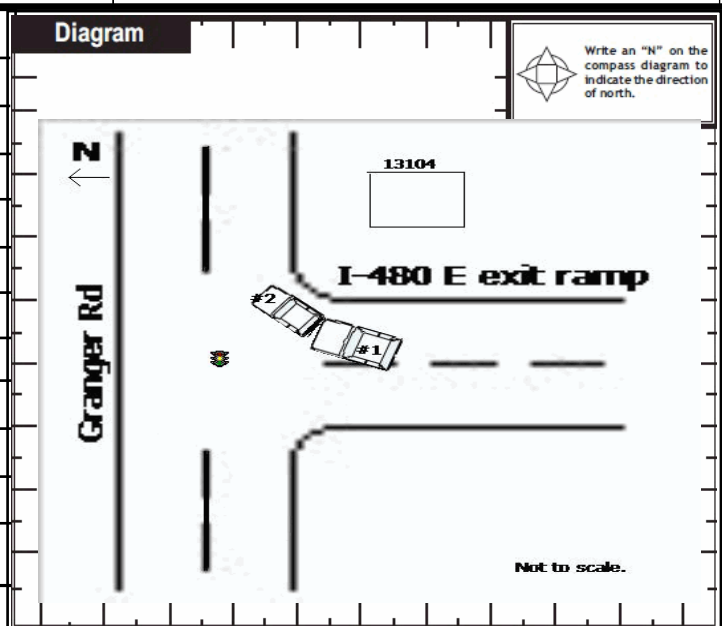

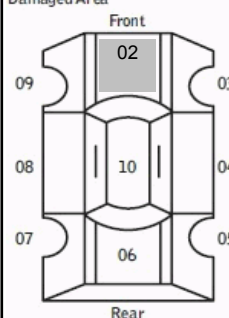

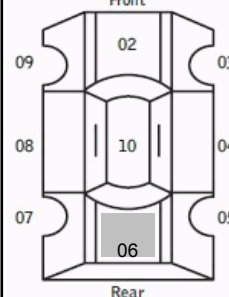

OSP PETERSON #532 STATED HE SAW UNIT #1 STRIKE UNIT #2 WHILE EXITING I480. HE THEN STOPPED TO ASSIST AS I WAS TRAVELING ON GRANGER.
