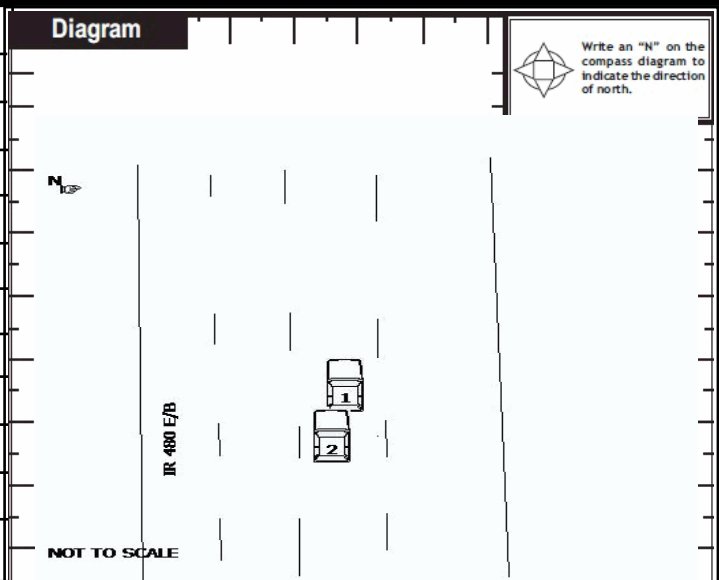

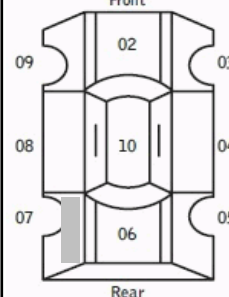
UNIT 1 WAS E/B ON IR480 IN LANE #3 IN HEAVY TRAFFIC.

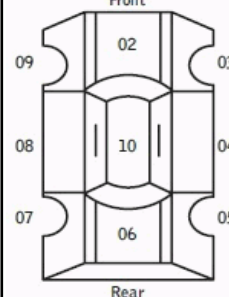
