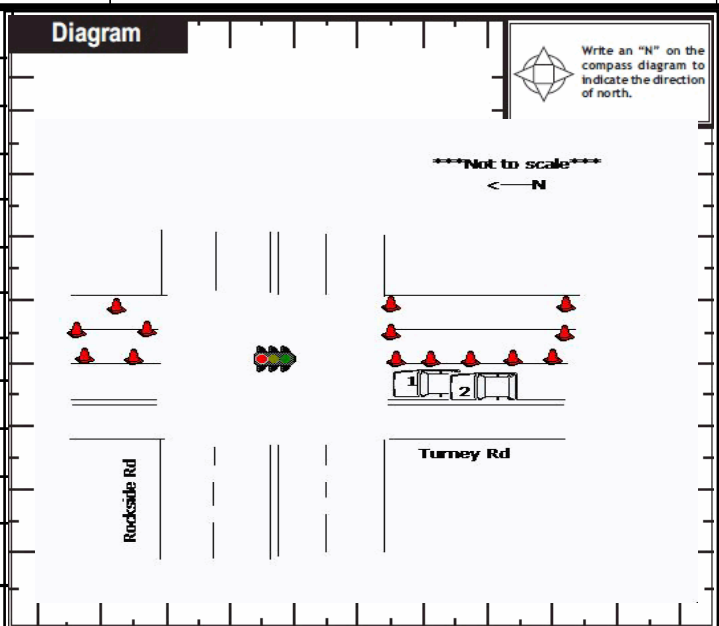

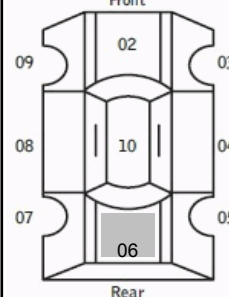

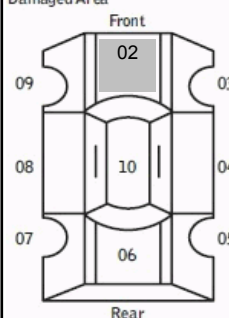
**Narrative**  
 DRIVER OF UNIT #1 STATED HE WAS STOPPED AT THE RED LIGHT ON TURNEY ROAD N/B AT ROCKSIDE ROAD. DRIVER OF UNIT #2 STATED SHE WAS STOPPED DIRECTLY BEHIND UNIT #1, LOOKED DOWN AT SOMETHING INSIDE HER VEHICLE, AND TOOK HER FOOT OFF THE BRAKE. THUS, UNIT #2 STRUCK UNIT #1 CAUSING MINOR DAMAGE TO BOTH VEHICLES. BOTH VEHICLES WERE ABLE TO BE DRIVEN AWAY AFTER THE CRASH.
