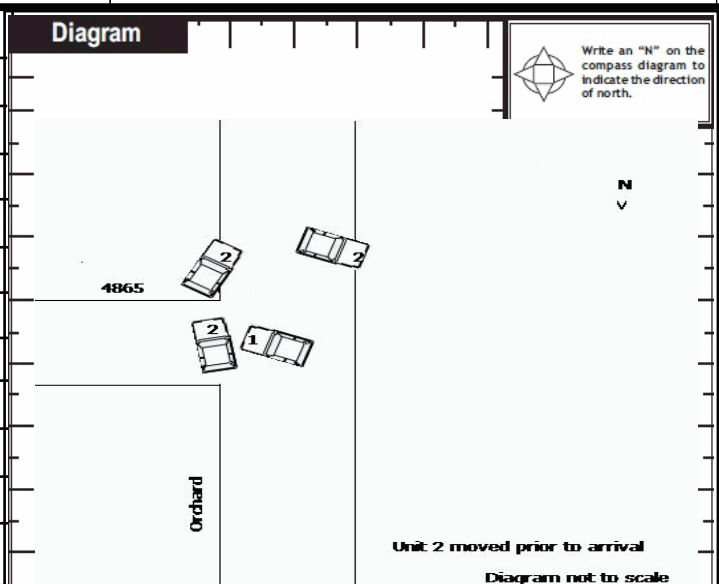

DRIVER OF UNIT 1 STATES HE WAS TRAVELING S/B ON ORCHARD AND BEGAN TO MAKE A LEFT TURN (E/B) INTO THE DRIVEWAY OF 4865. AS HE WAS ALMOST IN THE DRIVEWAY, UNIT 2 ATTEMPTED PASS HIM ON THE LEFT AND STRUCK UNIT 1.

DRIVER OF UNIT 2 STATES SHE WAS TRAVELING S/B ON ORCHARD BEHIND UNIT 1. UNIT 1 STOPPED IN THE ROADWAY AND AS UNIT 2 BEGAN TO PASS UNIT 1, UNIT 1 BEGAN TO TURN LEFT AND UNIT 1 AND UNIT 2 STRUCK.



While on scene the driver of unit 2 disputed the events that had taken place. She stated that the driver of unit 1 had stopped in the roadway for several minutes and she stopped behind him. After a short time of unit 1 remaining stationary, unit 2 decided to attempt to pass unit 1. As unit 2 began to pass, unit 1 began its left turn into the driveway causing both cars to strike each other. Upon checking the area, officers observed rust pieces lying in the roadway approximately 1 ft from the driveway edge. these rust pieces appeared to have come from the under carriage of the front left of unit 1 where it was struck indicating that unit 1 was almost in the driveway. Officers also observed what appeared to be skid marks from the tires of unit 2 that had travelled through the tree lawn of 4865 past the point of impact and grass lodged in the front tire of unit 2 indicated that unit 2 had spun around after the collision.
