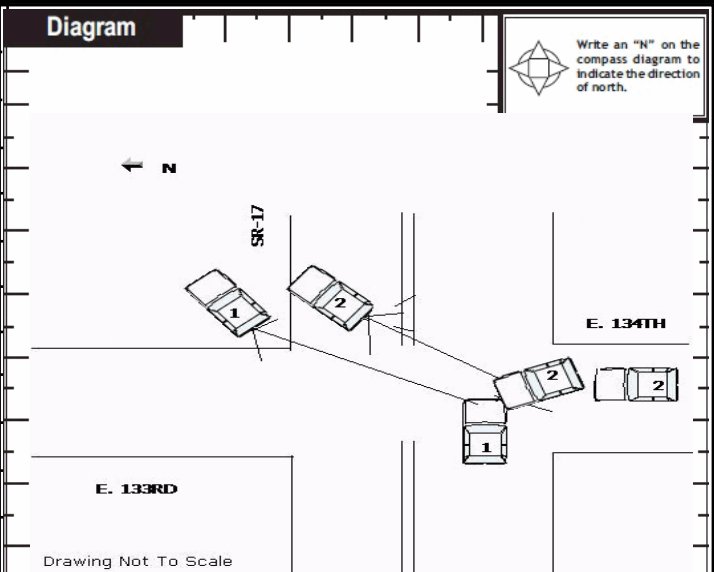

UNIT #1 WAS TRAVELING EAST ON SR-17 AT E. 134TH ST.

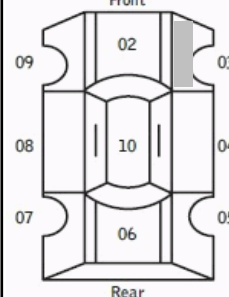
