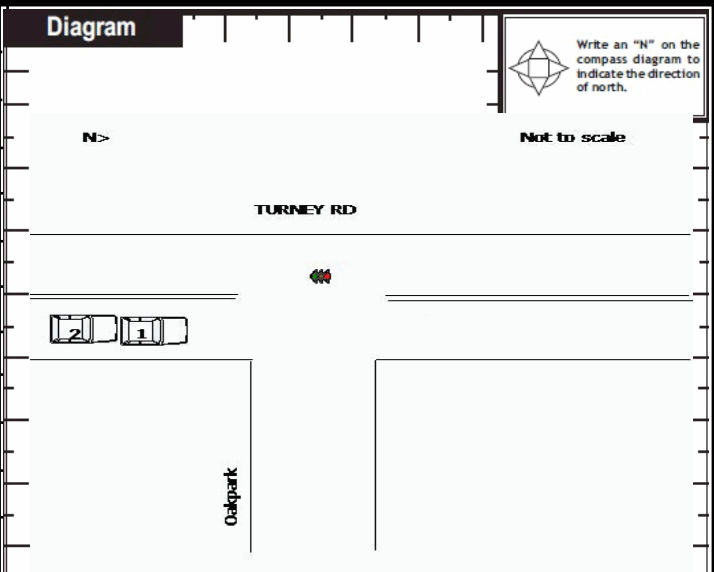





<p>Upon arriving on scene and speaking with the driver of unit 1, April Ulee. She advised that the driver of unit 2 had stopped briefly and spoken with her. He provided her with a photo of his Ohio DL that was later shown to me. The name of Robert Kapellas (RX273557) was obtained from the driver of unit 1 along with a photo of the Ohio registration of GRN4336 for unit 2. I was also given a phone number for Kapellas of 216-218-6029. Ulee advised that Kapellas gave her the above information along with \$250.00 cash and stated that "he was sorry he hit her car" and that "he had to leave because he had warrants". After obtaining the information from Ulee, I located a phone number for the owner of unit 2, Katherine Kapellas and later contacted her regarding the incident. Kapellas advised that her son Robert does drive the vehicle. On 6-22-17 I was contacted by Robert and he advised that he was in fact driving unit 2 at the time of the mva and his girlfriend was in the front passenger seat. Robert would not provide any information regarding the identity of his girlfriend to be added to the OH-1. He stated however that he believed at the time of the mva that Ulee began driving in reverse and struck his vehicle as a result. Robert was advised that he was going to be cited for the mva and refused to provide a current address or meet to be issued his citations due to his active warrant with CCSO for a probation violation.</p>
