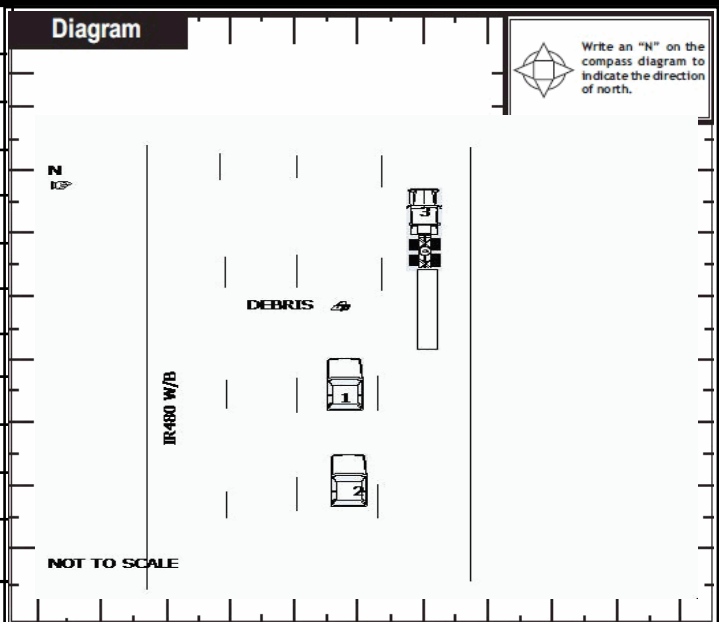

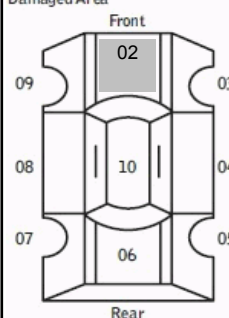


UNIT 3 WAS IN LANE 4, W/B ON IR480 JUST PAST SR 17 EXIT. UNIT 1 AND 2 WERE BEHIND UNIT 3 IN LANE 3. UNIT 3 LEFT TIRE BLEW WHICH CAUSED THE RUBBER TO STRIKE THE FENDER WHICH COVERED THE TIRE TO LOOSEN AND TEAR OF THE MOUNT. THE METAL FENDER THEN FELL TO THE ROAD WAY WHERE UNIT 1 AND 2 WERE UNABLE TO AVOID STRIKING THE METAL


