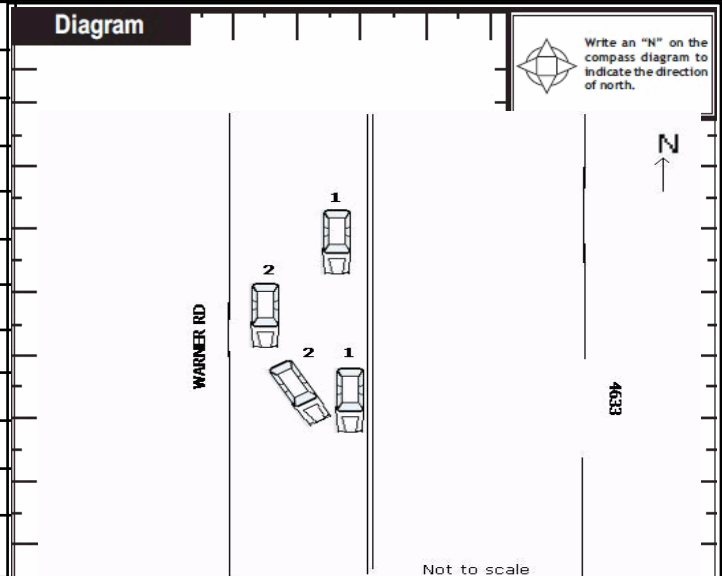

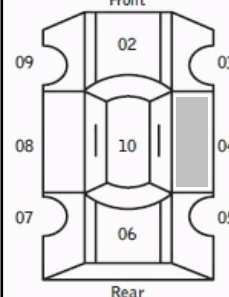

 UNIT 1 WAS TRAVELLING SOUTH ON WARNER RD AT 4633 WARNER WHEN UNIT 1 STATES THAT UNIT 2 WAS STOPPED IN THE ROADWAY WITH NO TURN SIGNAL OR HAZARD LIGHTS ON. BELIEVING UNIT 2 TO BE PARKED OR NOT OPERABLE, UNIT 1 ATTEMPTED TO PASS UNIT 2 ON UNIT 2'S LEFT. UPON PASSING UNIT 2, UNIT 2 MADE A LEFT TURN INTO UNIT 1'S PATH, STRIKING UNIT 1. UNIT 2 STATES THAT HE WAS STOPPED AWAITING A LEFT TURN INTO THE DRIVE OF 4633 WARNER. UPON TURNING, HE STRUCK UNIT 1 WHO WENT AROUND HIM AS HE WAS TURNING.
