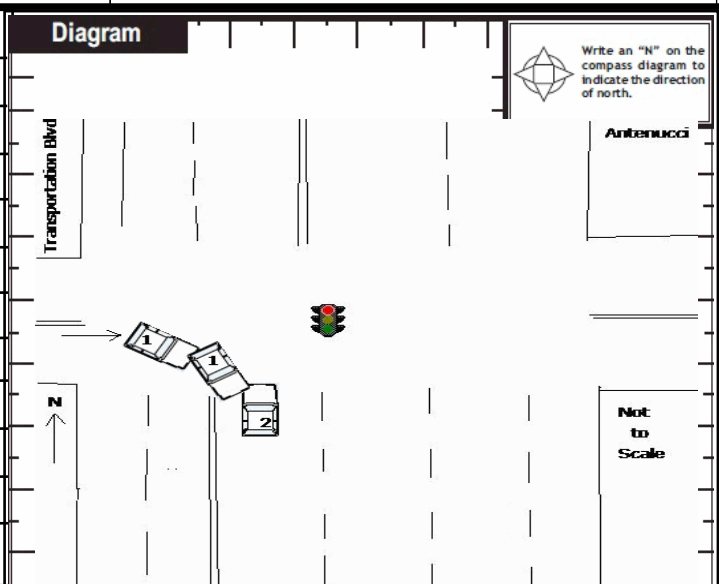

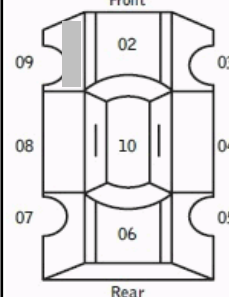

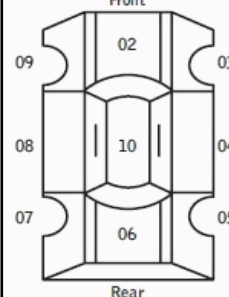

AS UNIT #1 TURNED, IT DID NOT LEAVE ENOUGH SPACE BETWEEN UNIT #1 AND UNIT #2. THIS CAUSED UNIT #1'S FRONT-RIGHT SIDE TO COME IN CONTACT WITH THE LEFT-FRONT SIDE OF UNIT #2.
 AFTER THE COLLISION, THE OPERATOR OF UNIT #1 LEFT THE SCENE, BUT WAS LATER FOUND BY OFFICERS.
