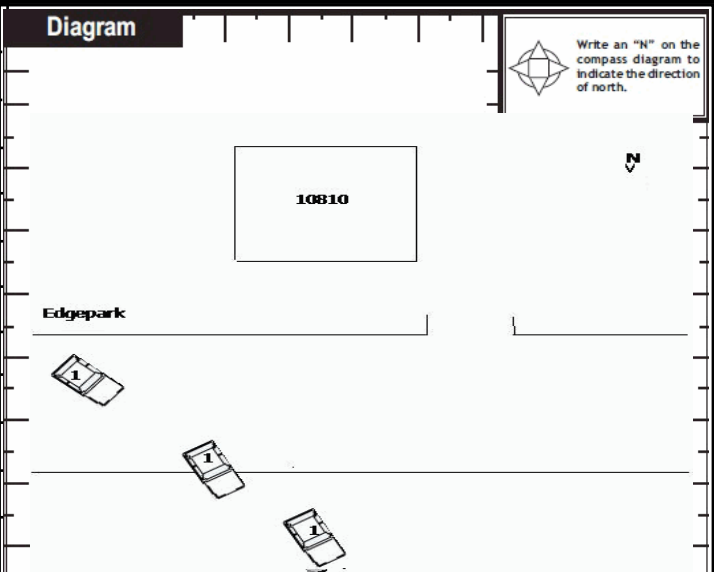

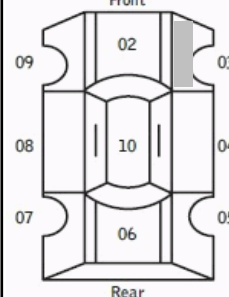

A witness to the mva, Alan Stebner stated he was parked in the gravel area along the north side of Edgepark across from E. 108. He heard a loud screaming noise coming from behind him. He turned and observed a blue Ford Explorer traveling a what "appeared to be a high rate of speed". The vehicle then began to swerve out of control and ran off the road, across a gravel parking area and struck a tree head on. The driver, a w/m, exited the vehicle, looked at the damage and then got back into the vehicle and began to travel w/b on Edgepark past Stebner. When the vehicle reached E. 106, the driver stopped and exited the vehicle and attempted to "make some repairs". The driver then got back into the vehicle and turned n/b on Edgepark in an attempt to leave the area. The vehicle was located at Edgepark and Turney by Ptl. Cwiklinski and fled the area with Ptl. Cwiklinski pursuing (see arrest report).
