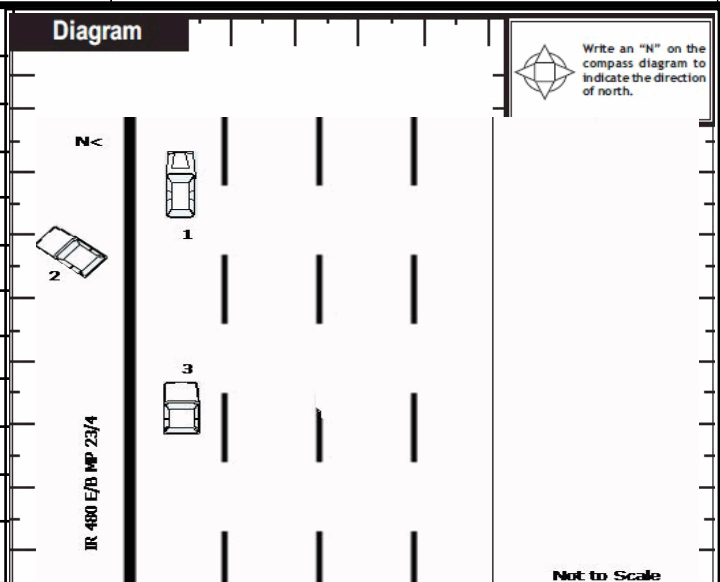




Narrative

ALL 3 UNITS WERE TRAVELLING ON IR480 E/B NEAR 23/4 IN LANE #1 HEAVY TRAFFIC. UNITS 1 & 2 WERE STOPPED WHEN UNIT 3 REAR-ENDED UNIT 2 WHICH REAR-ENDED UNIT 1. UNIT 1 SUFFERED MINOR DAMAGE TO THE LEFT REAR BUMPER. UNIT 2 SUFFERED SEVERE DISABLING REAR END DAMAGE AND DRIVER WAS INJURED AND TRANSPORTED BY GHFD TO MARYMOUNT HOSPITAL. UNIT 3 SUFFERED SEVERE DISABLING FRONT END DAMAGE BUT DRIVER UNINJURED. UNITS 2 & 3 TOWED BY A&H TOWING.
