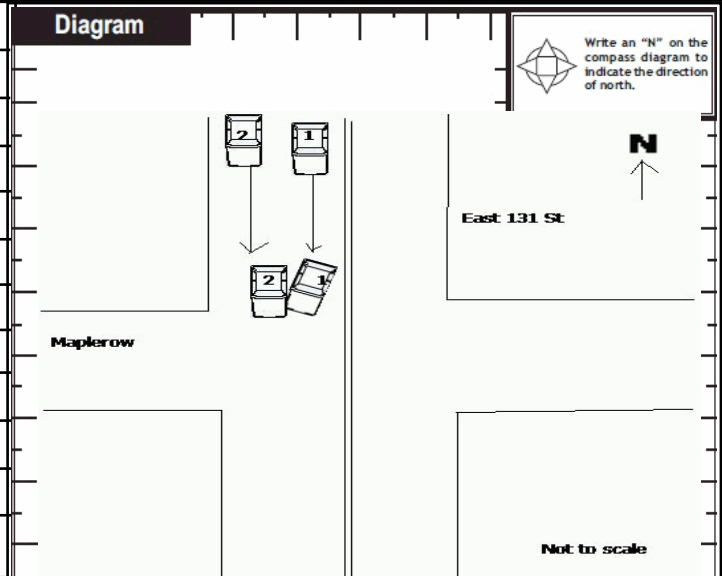

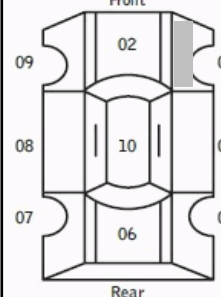


Narrative

UNIT 1 WAS TRAVELING SOUTH ON E. 131 ST WHICH IS A ONE LANE ROAD. UNIT 2 WAS TRAVELING NEXT TO UNIT 1 ON E. 131 AS THEY APPROACHED MAPLEROW UNIT 2 STATED THAT THEY WENT BEHIND UNIT 1. UNIT 2 STATED THAT UNIT 1 SLOWED AND BELIEVED THEY WERE GOING TO TURN LEFT ON TO MAPLEROW AND CONTINUED PAST UNIT 1 ON THE RIGHT. UNIT 1 THEN MADE A RIGHT TO GO ON TO MAPLEROW AND STRUCK UNIT 2 AS IT PASSED.
