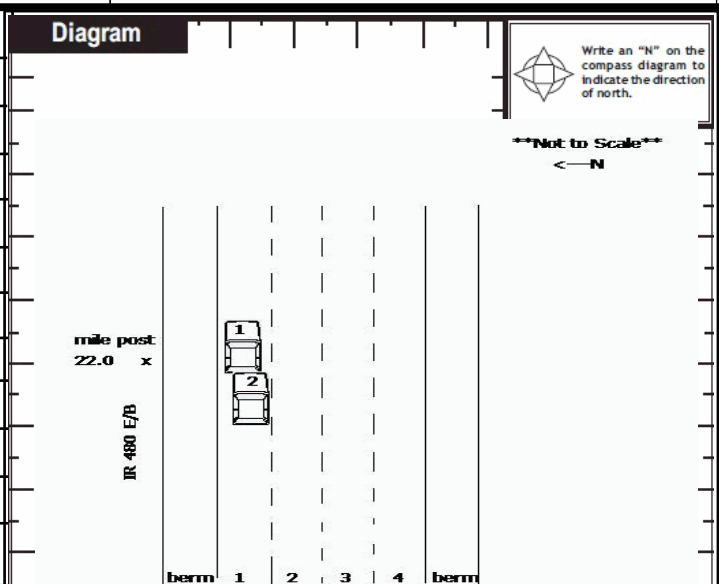

HE CAME TO A STOP DUE TO TRAFFIC AHEAD OF HIM STOPPING, THUS HIS VEHICLE WAS STRUCK BY UNIT #2. DRIVER OF UNIT #2 STATED SHE WAS TRAVELLING DIRECTLY BEHIND UNIT #1, DIDN'T NOTICE TRAFFIC AHEAD COMING TO A STOP AND STRUCK UNIT #1. UNIT #2 WAS DISABLED AND TOWED FROM THE CRASH SCENE.

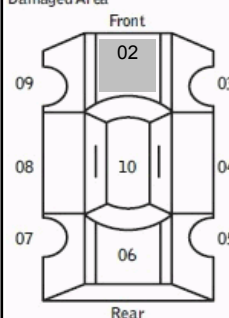
