
**Narrative**  
 UNIT #1 WAS TRAVELING EAST ON IR 480 AND SLOWED FOR TRAFFIC IN THE INSIDE LANE. UNIT #2 WAS DIRECTLY BEHIND UNIT #1. UNIT #3 WAS DIRECTLY BEHIND UNIT#2. AS A RESULT, THE FRONT OF UNIT #2 COLLIDED WITH THE REAR OF UNIT #1. UNIT #1 ROTATED CLOCKWISE INTO THE INSIDE MIDDLE LANE. UNIT #3 TOOK EVASIVE ACTION AND TRAVELED INTO THE INSIDE MIDDLE LANE. THE FRONT OF UNIT #3 COLLIDED WITH THE RIGHT SIDE OF UNIT #1. UNITS WERE AT FINAL REST UPON ARRIVAL.
