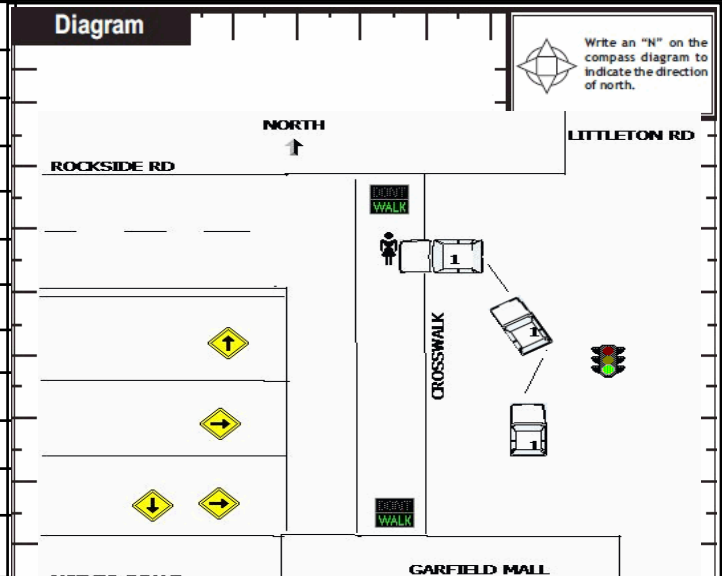


UNIT #1 WAS EXITING THE PARKING LOT OF GARFIELD MALL AND MAKING A LEFT-HAND (W/B) TURN ONTO ROCKSIDE ROAD TO THE INSIDE LANE. AS UNIT #1 CONTINUED THROUGH THE TURN, THE OPERATOR DID NOT SEE UNIT #2 (PEDESTRIAN) WALKING THROUGH THE INTERSECTION. THIS CAUSED UNIT #1'S FRONT-END TO COME IN CONTACT WITH UNIT #2.

THE PEDESTRIAN DID NOT HAVE ANY VISIBLE INJURIES. THE DAMAGE TO UNIT #1 WAS VERY MINOR.
