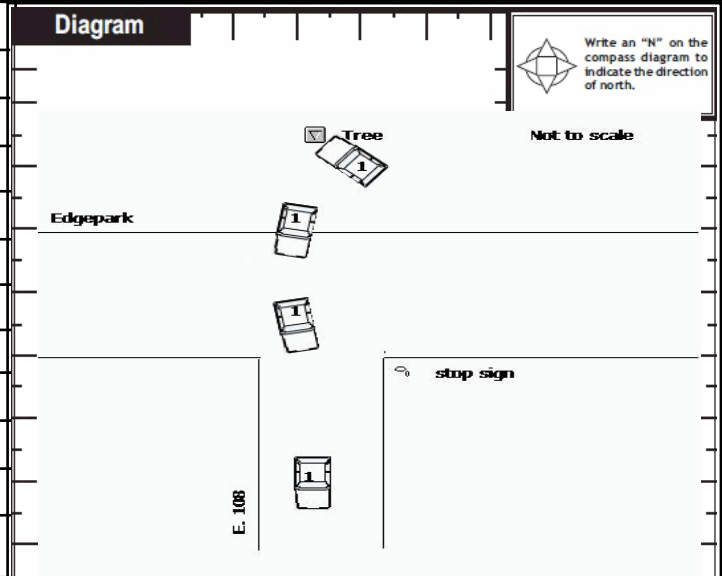



 DRIVER OF UNIT 1 STATES HE WAS IN THE VEHICLE WITH THE LISTED PASSENGER AND A PHYSICAL ALTERCATION BEGAN BETWEEN THE TWO DUE TO ONE MALE ATTEMPTING TO "ROB" THE OTHER. DURING THE ALTERCATION, THE DRIVER OF UNIT 1 LOST CONTROL OF THE VEHICLE AS IT TRAVELED W/B ON EDGE PARK NEAR E. 108. THE VEHICLE LEFT THE ROADWAY AND TRAVELED N/B OVER THE GRAVEL CURB AREA ALONG THE NORTH EDGE OF EDGE PARK AND STRUCK A TREE. AFTER IMPACT UNIT 1 CONTINUED DRIVERLESS S/B ON E. 108 WHERE IT CAME TO REST NEAR 4919 E. 108.
