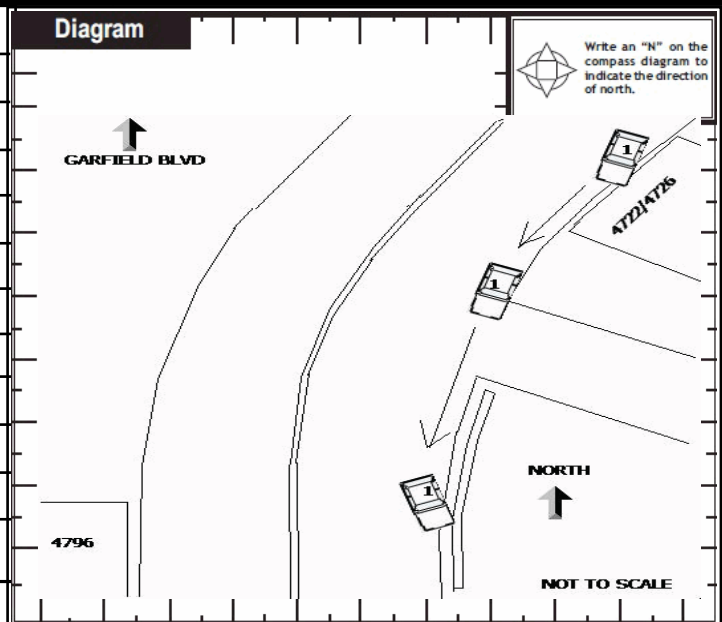



<p>Officers were dispatched to the area of 4796 Warner Road, for a report of a vehicle into a guardrail. Officers arrived on scene and located the vehicle (Chevy Equinox) (Tennessee registration 550-VTZ) with an unconscious male in the driver's seat. Officers called for EMS and GHFD Squad / Engine 1 responded to provide medical care. The male was transported to Metro Hospital and later identified as Calvin Martin. After investigating the scene, it appears Unit One was traveling S/B on Warner Road from Garfield Boulevard. Unit One lost control and went left of center into the N/B lanes. Unit One then jumped the curb, left the roadway and struck the fences belonging to 4722 and 4726 Blythin Road. Unit one then continued southbound on Warner Road, until it struck the guardrail across from 4796, where it came to a rest.</p>
