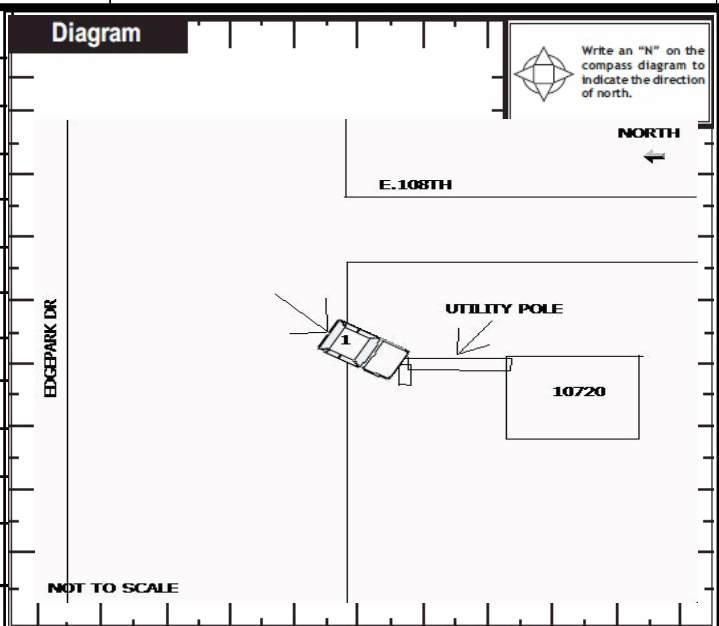

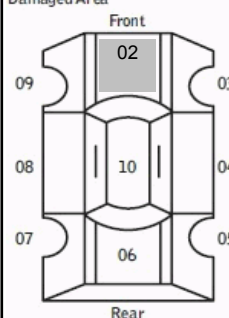

Narrative

GHPD OFFICERS RESPONDED TO 10720 EDGE PARK FOR REPORTS OF A VEHICLE THE STRUCK A UTILITY POLE. UPON ARRIVAL OFFICERS OBSERVED A TAN NISSAN SENTRA WITH HEAVY FRONT END DAMAGE. THE VEHICLE STRUCK A UTILITY POLE IN FRONT OF 10720 EDGE PARK. THE FORCE OF THE IMPACT CAUSED THE POLE TO SNAP AT THE BOTTOM AND FALL ONTO THE ROOF OF 10720 EDGE PARK CAUSING DAMAGE TO THE ROOF. WITNESSES STATED THAT THE MALE OPERATOR FLED FROM THE VEHICLE. THE OPERATOR WAS FOUND AT E.109 AND LANGTON AND ARRESTED FOR OVI. (SEE REPORT)
