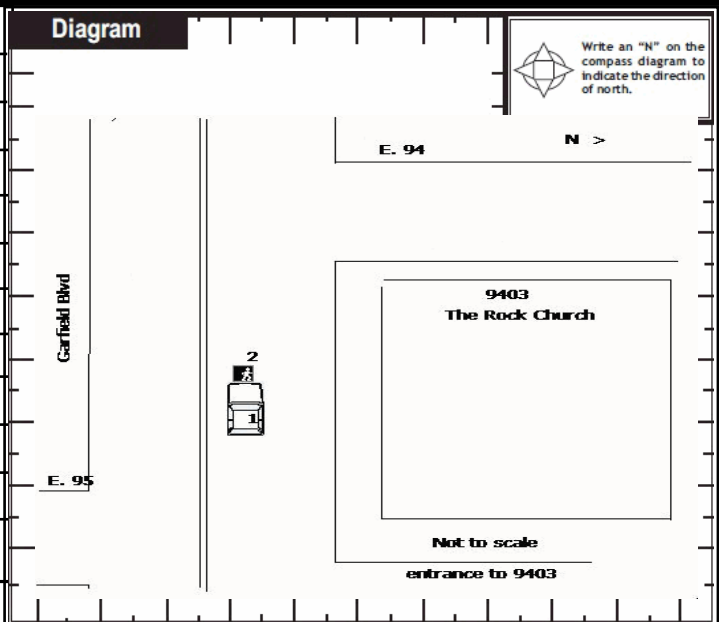

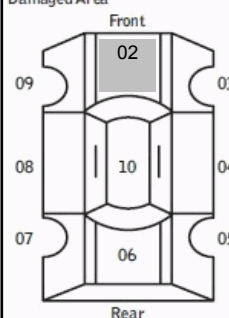

HOWEVER, UNIT 1 WAS UNABLE TO TAKE EVASIVE ACTION IN TIME AND STRUCK UNIT 2.
