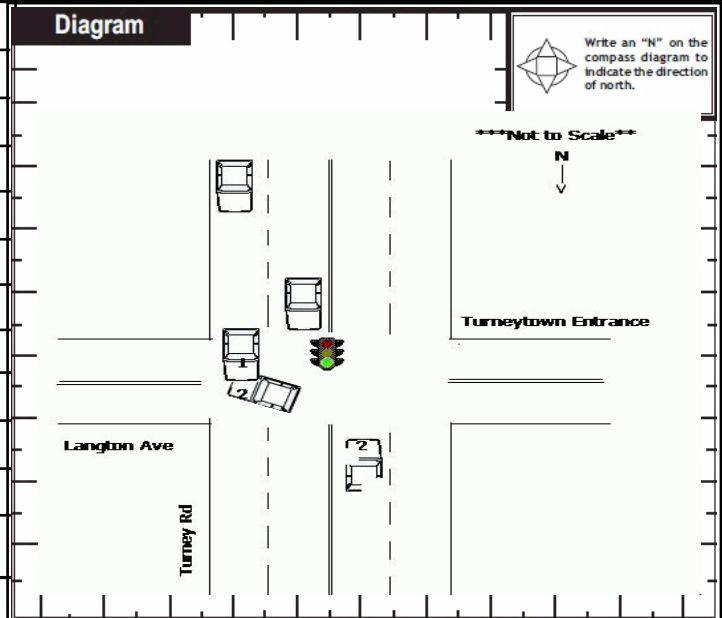

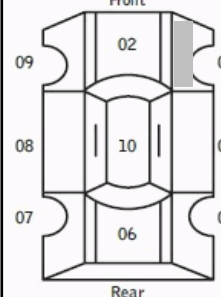

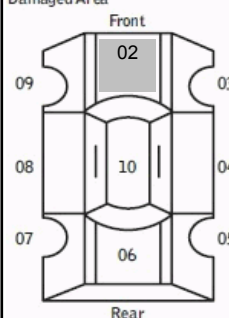

 DRIVER OF UNIT #1 STATED HE WAS TRAVELLING ON TURNEY RD N/B IN THE CURB LANE APPROACHING LANGTON AVE WHEN UNIT #2 CAME FROM THE OPPOSITE DIRECTION AND TURNED IN FRONT OF HIM. THUS, HIS VEHICLE STRUCK UNIT #2. DRIVER OF UNIT #2 STATED SHE WAS DRIVING ON TURNEY RD S/B, TURNED LEFT AT THE INTERSECTION OF LANGTON AVE(E/B) AND THE ACCIDENT OCCURRED. SHE ALSO STATED SHE THOUGHT THERE WAS ENOUGH TIME TO TURN AND NOT HAVE AN ACCIDENT. BOTH DRIVERS STATED THE LIGHT WAS GREEN ON TURNEY RD. TWO WITNESSES BEHIND UNIT #1 STATED THE LIGHT WAS GREEN WHEN THE CRASH
