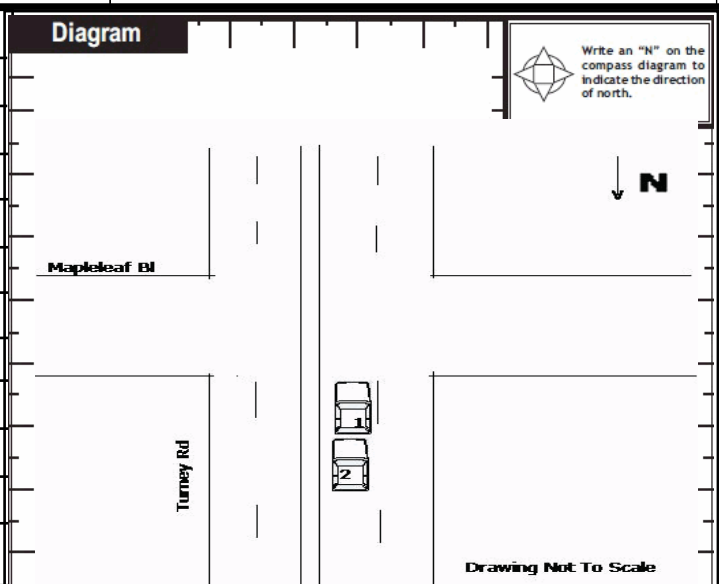

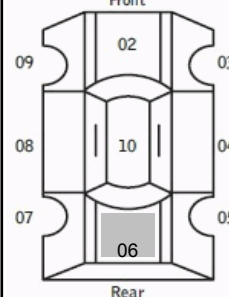

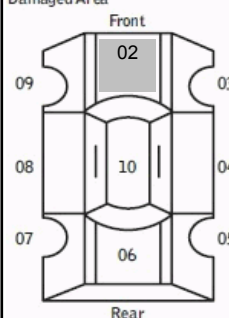
Narrative
