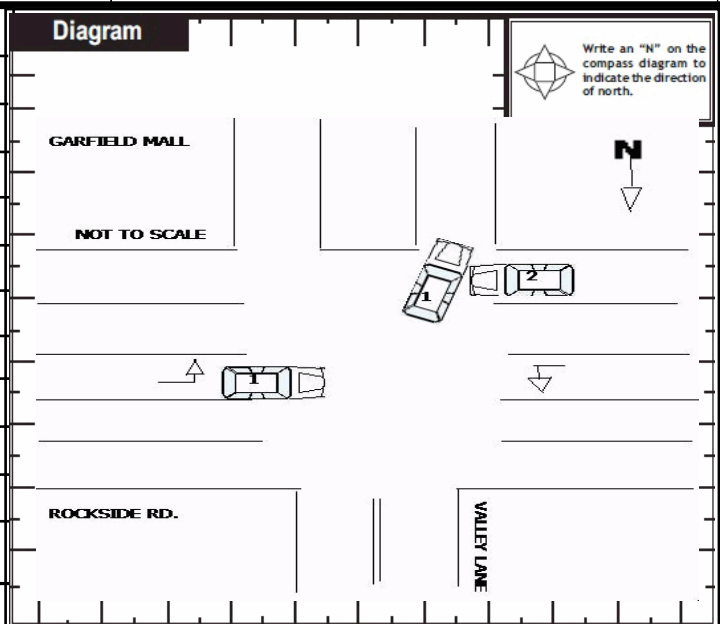




Narrative

UNIT #1 WAS TRAVELING W/B ON ROCKSIDE RD. AND PULLED INTO THE LEFT TURN LANE TO TURN INTO GARFIELD MALL AND THE DRIVER STATED SHE HAD A GREEN ARROW OR GREEN LIGHT BEGAN TO TURN AND WAS STRUCK BY UNIT#2 WHO SHE STATED RAN A RED LIGHT. UNIT#2 WAS TRAVELING E/B ON ROCKSIDE IN THE CURB LANE AND STATED HIS LIGHT WAS TURNING YELLOW AND UNIT#1 TURNED IN FRONT OF HIM CAUSING UNIT#2 TO CRASH INTO THE PASSENGER SIDE OF UNIT#1.
