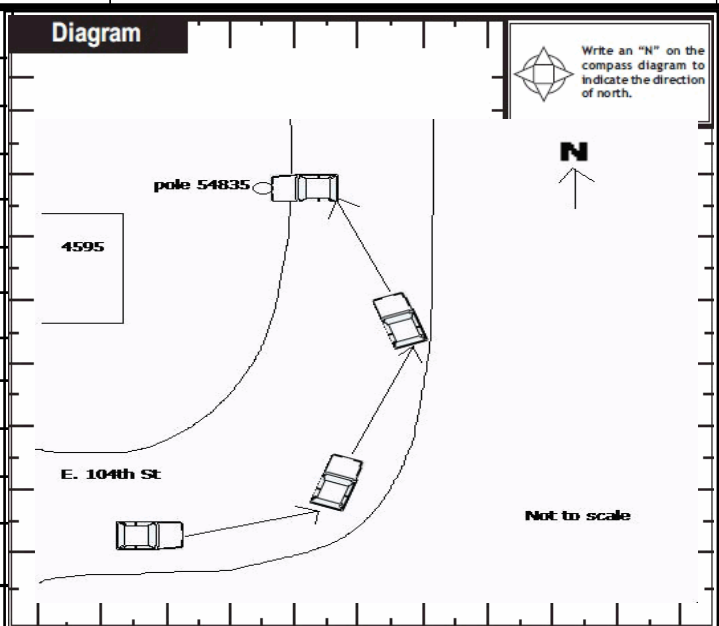

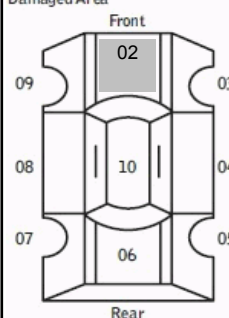

 UNIT 1 WAS TRAVELING NORTH ON E. 104 ST. UNIT 1 LOST CONTROL WHILE COMING AROUND A BEND AND STRUCK A WOODEN UTILITY POLE ( 54835). BOTH OCCUPANTS WERE OUT OF THE VEHICLE UPON OFFICERS ARRIVAL. BOTH PARTIES STATED THAT THEY WERE NOT DRIVING WHEN THE CRASH OCCURRED AND THAT AN UNKNOWN FEMALE WAS DRIVING WHO RAN OFF WAS. UPON SPEAKING FURTHER WITH THE PARTIES SUMMER BOGGANS STATED THAT SHE WAS THE FRONT SEAT PASSENGER AND MITCHELL BYERS WAS DRIVING THE CAR. MR BYERS DENIED DRIVING THE CAR AT ALL AND CONTINUED STATING ANOTHER FEMALE WAS DRIVING.
