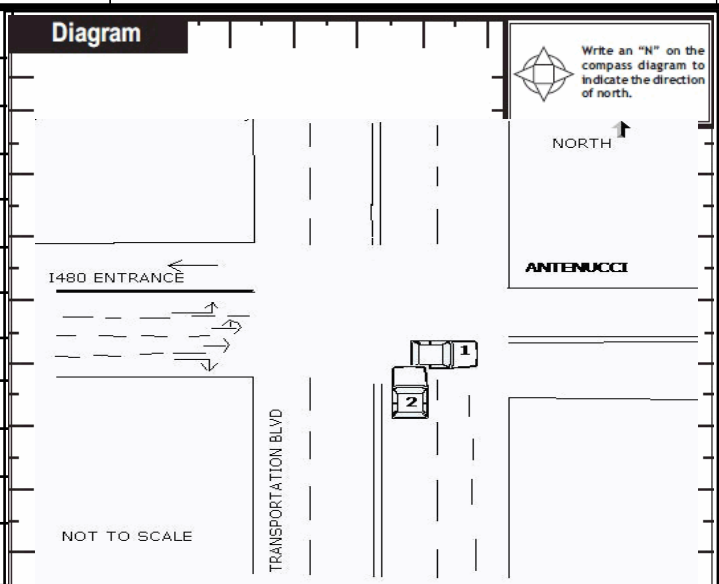





UNIT 2 WAS TRAVELING NORTH BOUND ON TRANSPORTATION AT ANTENUCCI WHEN UNIT 2 STRUCK UNIT 1'S RIGHT REAR SIDE. UNIT ONE STATED THAT UNIT 2 WENT THROUGH A RED LIGHT. UNIT 2 STATED THAT SHE HAD A GREEN LIGHT AND UNIT 1 WENT THROUGH A RED LIGHT. IT WAS UNDETERMINED WHOM WAS AT FAULT.
