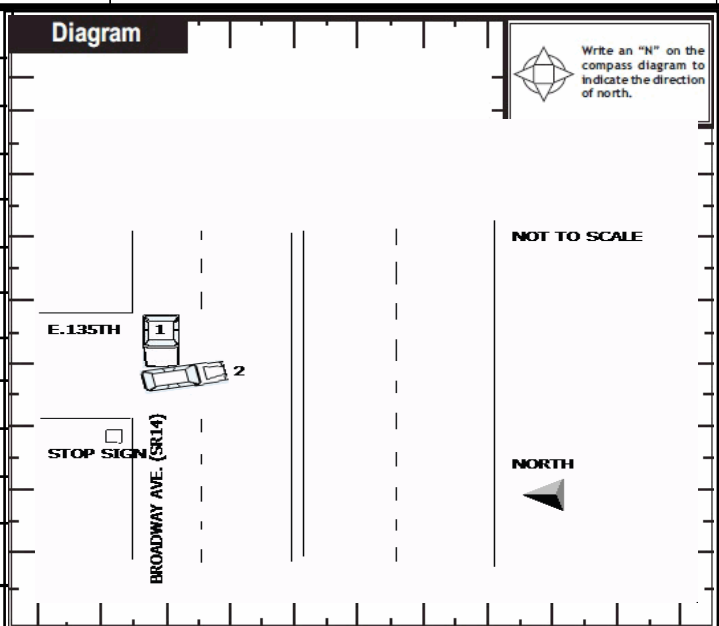




Narrative

UNIT #1 STATED WHILE TRAVELING WEST ON BROADWAY AVE. (SR14) UNIT #2 STRUCK THE FRONT LEFT AREA OF HER VEHICLE WHILE TURNING LEFT FROM E. 135TH ST. UNIT #1 STATED THAT UNIT #2 THEN FLED EAST ON BROADWAY (SR14). THOMAS GALVIN (WITNESS) STATED THAT HE WAS DIRECTLY BEHIND UNIT #1 WHEN HE OBSERVED WHAT APPEARED TO BE A BLUE JEEP SW STRIKE THE FRONT OF HER VEHICLE AND FLEE EAST BOUND. UNIT #1 STATED THAT A UNKNOWN FEMALE THEN RESPONDED TO THE SCENE WITH OHIO REGISTRATION GRN6035 WHICH SHE STATED BELONGED TO UNIT #2.
