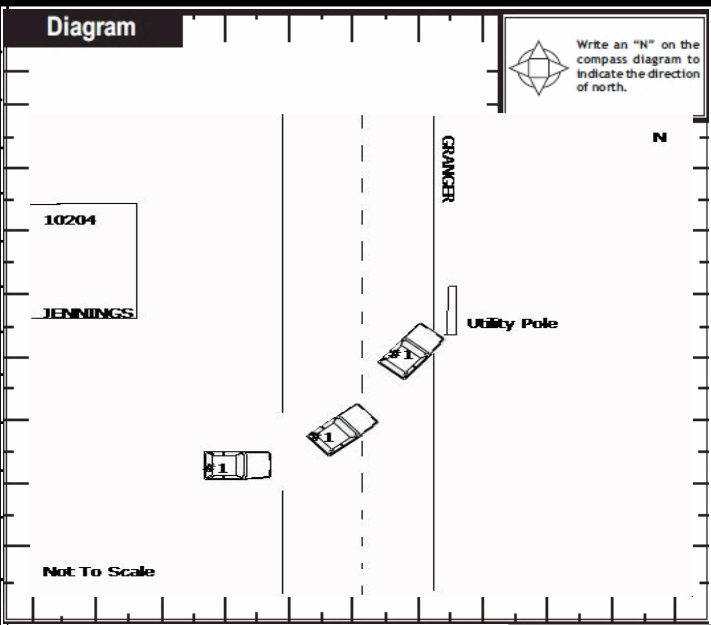



UNIT #1 WAS MAKING A LEFT HAND TURN TO HEAD WEST ONTO GRANGER RD. AND THE DRIVER STATED ANOTHER VEHICLE WAS COMING TOWARDS HER AND SHE GOT SCARED.
