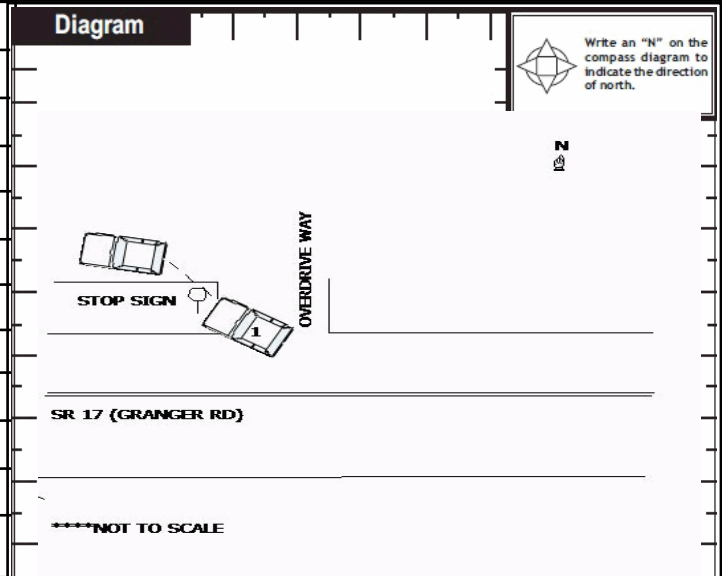

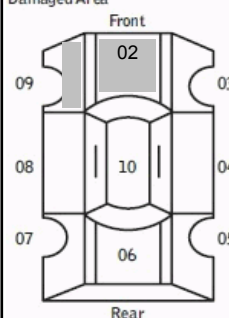

UNIT 1 WAS TRAVELING W/B ON SR 17 (GRANGER RD).
THE DRIVER WAS DISTRACTED BY HIS GPS NAVIGATION SYSTEM AND ATTEMPTED TO MAKE A RIGHT TURN ONTO OVERDRIVE WAY AT THE LAST SECOND. UNIT 1 LOST CONTROL AND DROVE OVER THE CURB ON THE WEST SIDE OF OVERDRIVE WAY. UNIT 1 CONTINUED OVER THE GRASS AND STRUCK TWO STOP SIGNS. UNIT 1 HAD A DRIVER SIDE FRONT TIRE THAT WAS FLAT AND DAMAGE TO THE FRONT END. THE TWO STOP SIGNS AND PART OF THE LAWN WAS DAMAGED.
