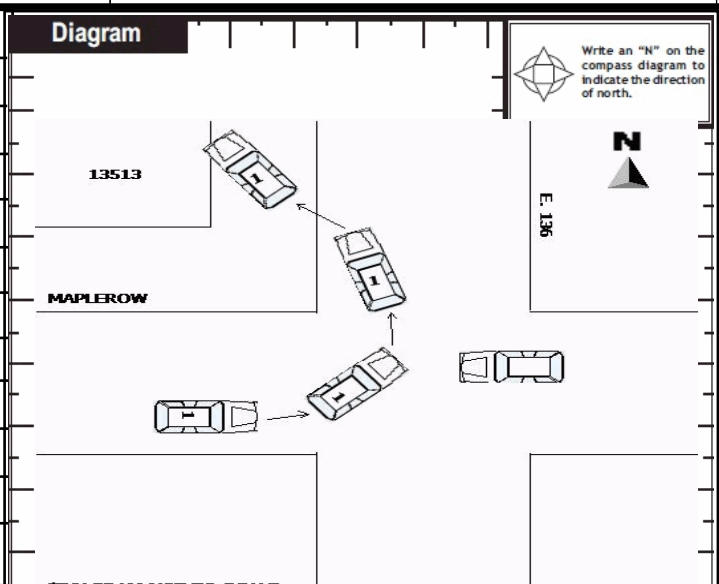

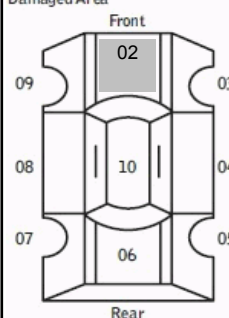
Narrative

UNIT 1 WAS STOPPED FOR THE STOP SIGN ON E/B MAPLEROW AT E. 136 PREPARING TO TURN LEFT. UNIT 1 PROCEEDED INTO THE INTERSECTION TO TURN WHEN AN UNKNOWN UNIT TRAVELING W/B ON MAPLEROW PULLED INTO THE INTERSECTION. THE OPERATOR OF UNIT 1 ATTEMPTED TO SWERVE AROUND THE UNKNOWN UNIT AND THEN ACCELERATED WHILE TURNING LEFT ONTO E. 136. UNIT 1 LOST CONTROL CAUSING UNIT 1 TO CONTINUE TURNING LEFT AT A HIGH RATE OF SPEED. UNIT 1 DROVE OVER THE CURB ON THE NORTH SIDE OF E. 136 AND CONTINUED OFF THE LEFT SIDE OF THE ROADWAY WHERE IT STRUCK THE HOUSE AT 13513 E. 136.
