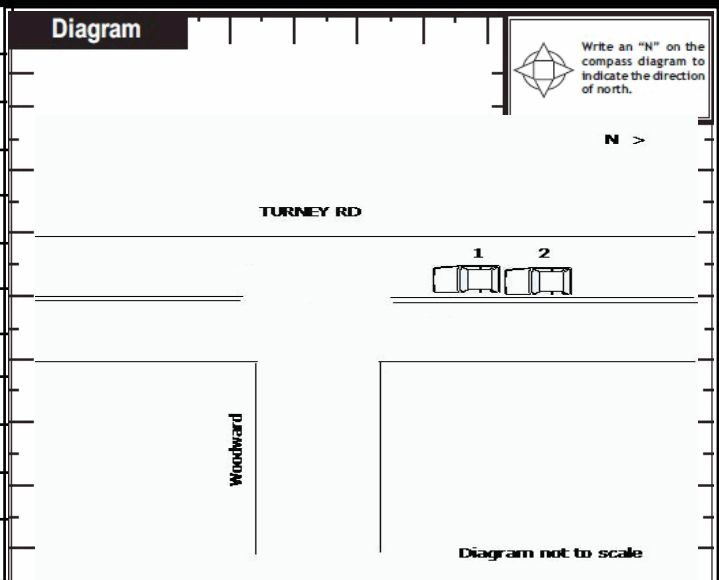

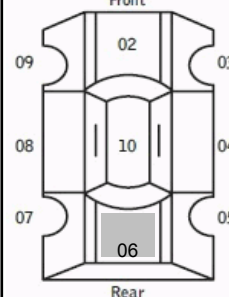

 DRIVER OF UNIT 1 STATES SHE WAS IN THE CENTER LANE, S/B ON TURNEY RD AND WAS STOPPED DUE TO A CAR IN FRONT OF HER ATTEMPTING TO TURN E/B ON WOOD WARD AND WAS STRUCK BY UNIT 2. DRIVER OF UNIT 2 STATES HE WAS TRAVELING IN THE CENTER LANE BEHIND UNIT 1 AND DID NOT SEE THAT SHE HAD STOPPED. HE ATTEMPTED TO STOP AND WAS UNABLE TO DO SO, CAUSING UNIT 2 TO STRIKE UNIT 1.
