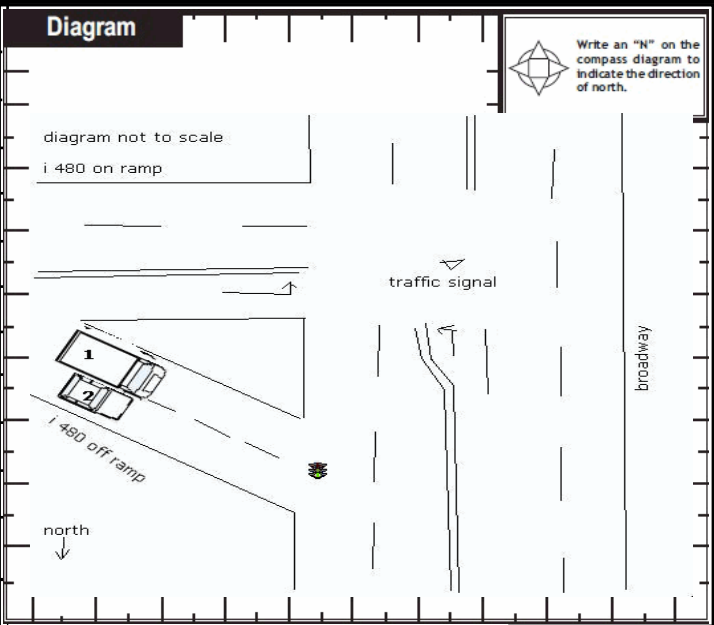




Narrative

UNIT #1 AND #2 WERE TRAVELLING S/B ON THE IR 480 EXIT RAMP NEAR BROADWAY. THE DRIVER OF UNIT #1 STATED UNIT #2 ATTEMPTED TO GET INTO HIS LANE WHEN IR 480 MERGES AND ALMOST STRUCK HIS VEHICLE. HE STATED HE SLAMMED ON HIS BRAKES AND WAS BEHIND UNIT #2. THE DRIVER OF UNIT #1 STATED AS THEY WENT DOWN THE RAMP HE WENT INTO THE LEFT LANE. UNIT #1 TURNED INTO HIS LANE STRIKING HIS VEHICLE. THE DRIVER OF UNIT #2 STATED UNIT #1 WENT INTO HER CURB(RIGHT) LANE STRIKING HER VEHICLE, DUE TO LACK OF INDEPENDENT WITNESS AND INCONCLUSIVE DAMAGE FAULT COULD NOT BE DETERMINED
