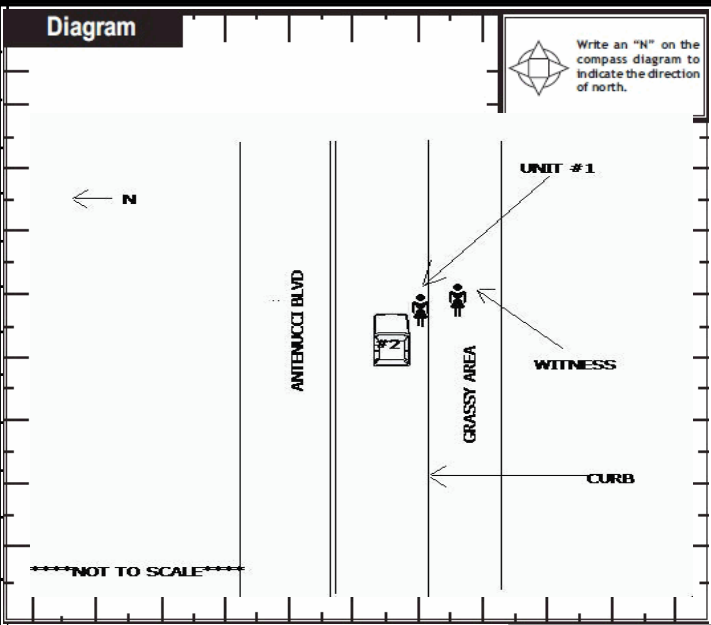

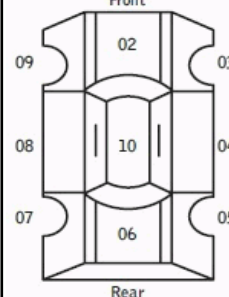

UNIT #2 WAS DRIVING E/B ON ANTENUCCI BLVD AND STRUCK UNIT #1 WITH THE RIGHT SIDE OF THE VEHICLE (POSSIBLY THE RIGHT MIRROR). UNIT #2 THEN CONTINUED E/B TOWARDS TURNEY RD. WITHOUT STOPPING. WITNESS STATED THAT UNIT #2 WAS A DARK COLORED SEDAN WITH DARK WINDOWS.
