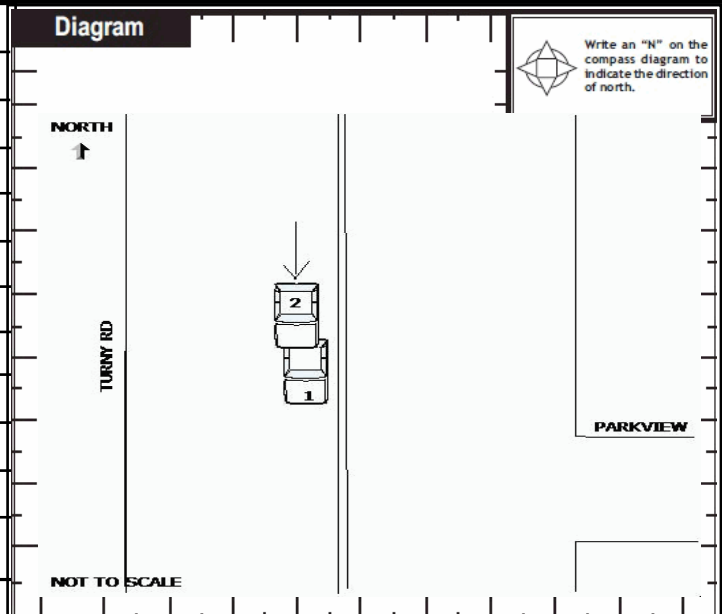

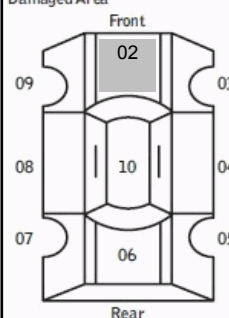
UNIT 1 STATED THAT WHILE TRAVELING SOUTH ON TURNEY RD IN THE LEFT LANE APPROACHING PARKVIEW AVE, THE VEHICLE INFRONT OF HER CAME TO A STOP TO TURN LEFT SO SHE SLOWED DOWN WHEN SHE WAS STRUCK IN THE CENTER REAR BY UNIT 2. UNIT 2 STATED THAT WHILE TRAVELING SOUTH ON TURNEY BEHIND UNIT 1, UNIT 1 STOPPED SUDDENLY IN TRAFFIC AND SHE WASNT ABLE TO STOP IN TIME. UNIT 2 STATED THAT SHE STRUCK UNIT 1 IN THE CENTER REAR WITH THE CENTER FRONT OF HER VEHICLE.


OPERATOR OF UNIT 1 WAS TRANSPORTED TO
