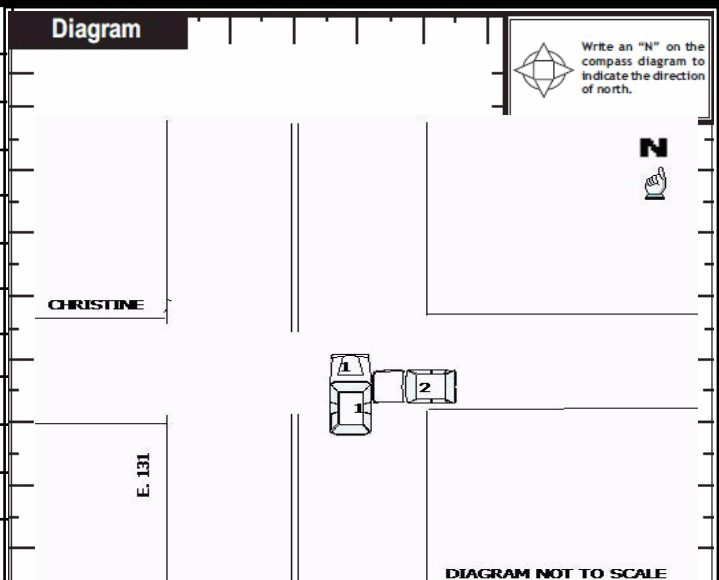

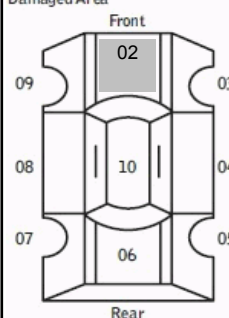


Narrative

UNIT 1 WAS TRAVELING N/B ON E.131ST AT CHRISTINE AVE. UNIT 1 WAS WAITING ON E.131 TO TURN LEFT ONTO CHRISTINE. UNIT 2 WAS TRAVELING WEST ON CHRISTINE AVE. APPROACHING E.131ST WHEN UNIT 2 TRAVELED THROUGH THE STOP SIGN AT CHRISTINE AND E.131ST THEN STRIKING UNIT 1 HEAD ON. THE DRIVER OF UNIT 2 THEN FLED THE SCENE. THE DRIVER OF UNIT 2 WAS DESCRIBED AS A TALL THIN BLACK FEMALE WITH TWO LONG BRAIDS.
