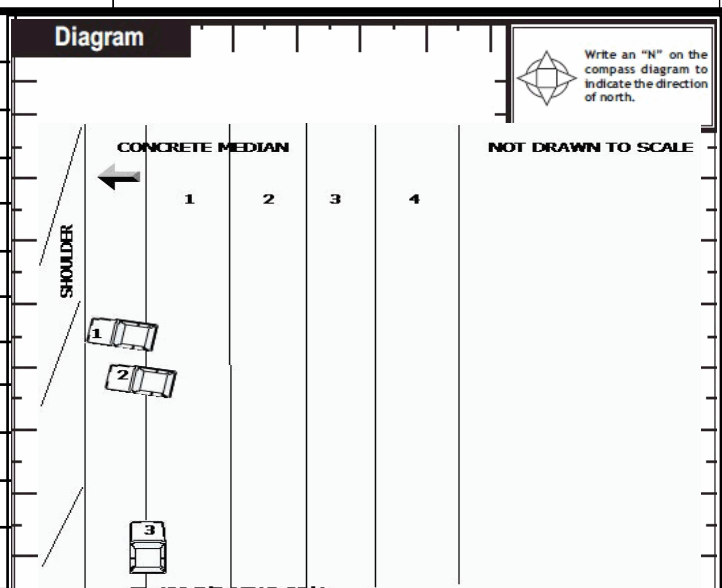



UNITS 1, 2, & 3 WERE TRAVELLING E/B ON IR 480 IN LANE #1. TRAFFIC WAS CONGESTED AND SLOWING. DRIVER OF UNIT 3 STATES SHE WAS TRAVELLING ABOUT 60 MPH WHEN SHE SAW TRAFFIC AHEAD OF HER SLOW SUDDENLY AND WAS UNABLE TO STOP IN TIME AND REAR-ENDED UNIT 2 WHICH IN TURN REAR-ENDED UNIT 1 SENDING UNIT 1 INTO THE CONCRETE MEDIAN.


