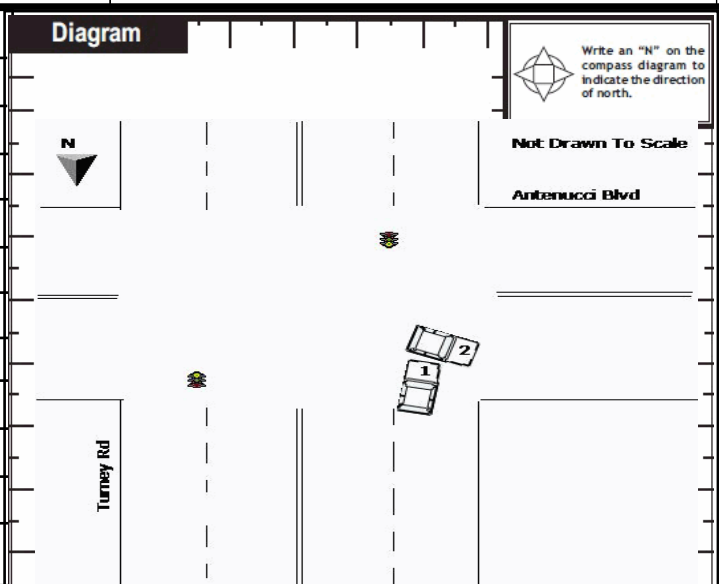



Driver of Unit 2 stated she had the right of way and initiated a left-hand turn on a green arrow, and was struck by Unit 1. Owner of Unit 2 claimed she was a front seat passenger in Unit 2 and corroborated the story of her daughter who was driver of Unit 2. Driver of Unit 2 has a valid temporary permit through the state of Ohio.</p> <p>Ptl Gall, Sgt Merchant, and Lt Bailey reviewed traffic camera video of the intersection at the time of the accident and observed Unit 2 completely fail to yield to oncoming (s/b) traffic and turn directly into the path of Unit 1 who had the right of way. Officers also observed that only one person, the driver, exited Unit 2 after the MVA. The owner of Unit 2 and mother of driver of Unit 2, arrived on scene nearly (12) minutes after the accident and was never in Unit 2 as she stated to Ptl Gall on scene and kept insisting even after confronted by Ptl Gall that she was not on scene upon his arrival.</p> <p>Driver of Unit 2 cited for failing to yield, and not having a licensed driver present while operating a motor vehicle with a temporary permit.
