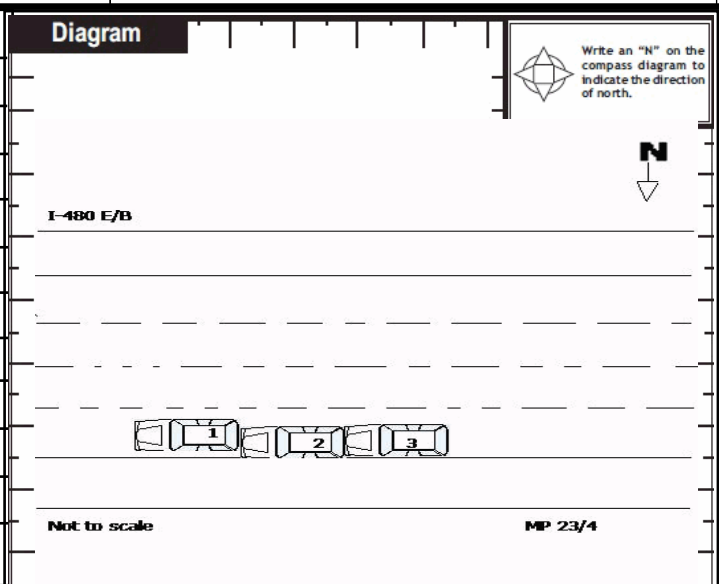

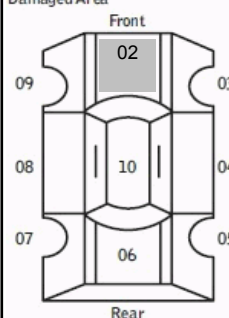

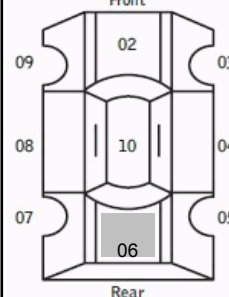
Narrative
