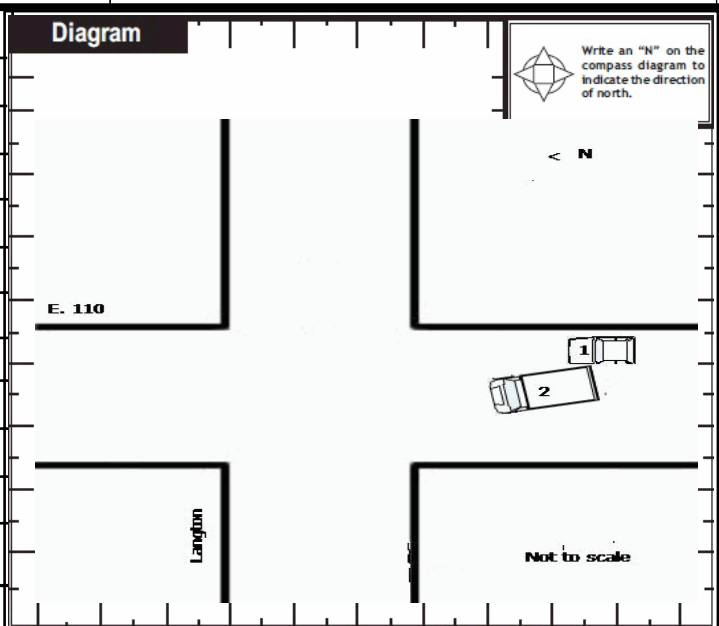

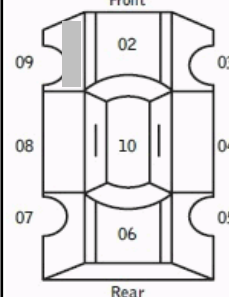

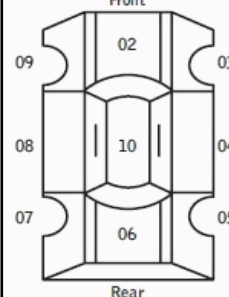

DRIVER OF UNIT 1 STATES UNIT 2, A GARFIELD HTS CITY SCHOOLS BUS #12, STOPPED AND DROPPED OF THE STUDENTS. AS UNIT 2 PULLED AWAY THE RIGHT REAR OF THE BUS SWUNG TOWARD UNIT 1 STRIKING IT.
