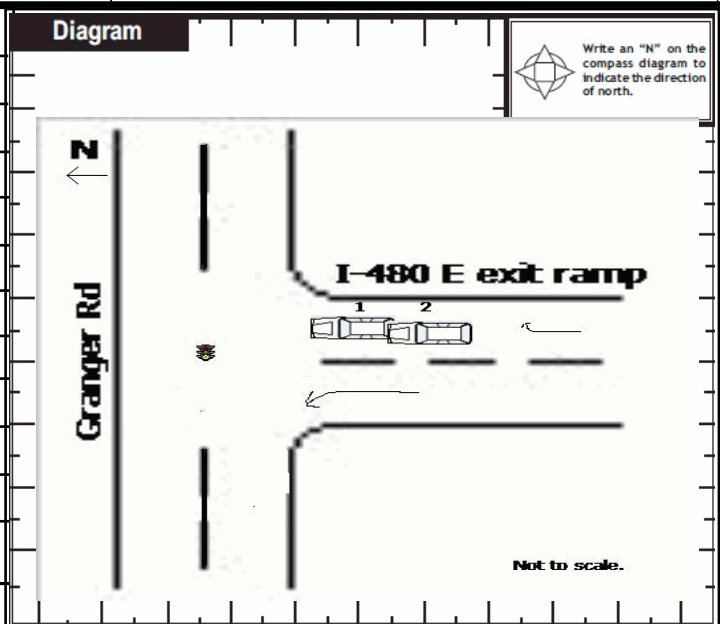



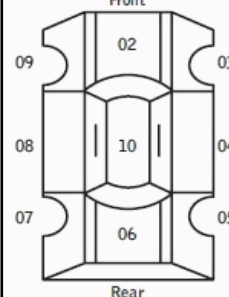
Narrative

UNIT 2 FOLLOWED TOO CLOSELY AND REAR ENDED UNIT 1 AS UNIT 1 WAS PREPARING A RIGHT HAND TURN ONTO GRANGER RD. DRIVERS OF BOTH VEHICLES EXCHANGED INFO AT THE SCENE. HOWEVER, THE DRIVER OF UNIT 2 FAILED TO PROVIDE A PHONE NUMBER OR POLICY NUMBER FOR HIS INSURANCE (NATIONWIDE).
