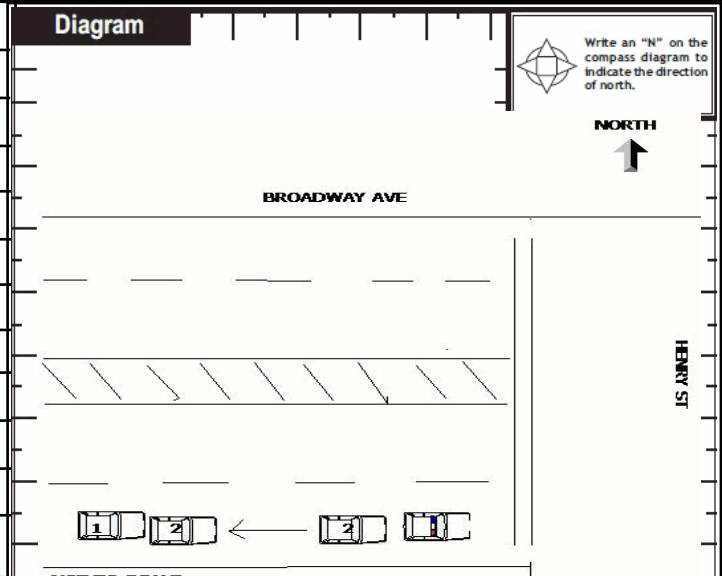

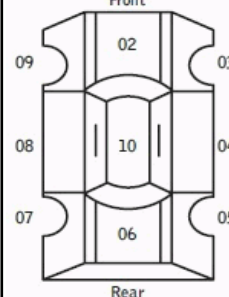

 UNIT ONE WAS TRAVELING BEHIND UNIT TWO ON BROADWAY AVE., HEADING EASTBOUND IN THE CURB LANE. AS BOTH UNITS APPROACHED THE INTERSECTION OF BROADWAY / HENRY, UNIT TWO STOPPED FOR A CLEVELAND METROPARK POLICE OFFICER WHO WAS STOPPED IN THE CURB LANE, WITH THEIR OVERHEAD EMERGENCY LIGHTS ACTIVATED. ACCORDING TO THE DRIVER OF UNIT ONE, SHE STOPPED BEHIND UNIT TWO WHO WAS STOPPED BEHIND THE MARKED POLICE UNIT. AS UNIT ONE WAS WAITING TO MERGE INTO THE CENTER LANE, UNIT TWO PUT THE VEHICLE IN REVERSE AND BACKED INTO THE FRONT OF UNIT ONE.
