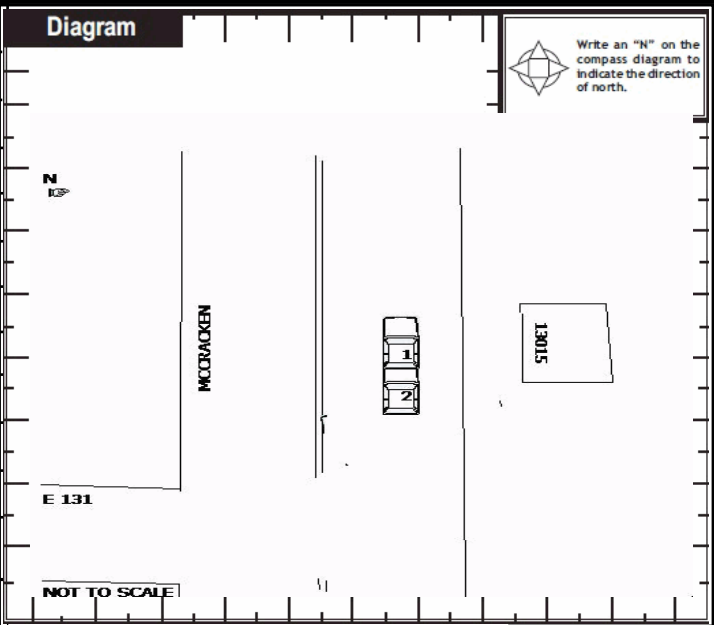





 UNIT 2 WAS W/B ON MCCRACKEN. UNIT 1 WAS A MARKED POLICE UNIT AND DISCOVERED THE DRIVER OF UNIT 2 WAS APPARENTLY UNABLE TO STOP HER VEHICLE. UNIT 1 THEN ACCERATED TO PASS UNIT 2 IN ORDER TO GET IN FRONT OF UNIT 2. UNT 1 WAS ABLE TO GET IN FRONT OF UNIT 2 TO ALLOW IT TO STRIKE UNIT 1 IN THE REAR TO SLOW IT DOWN IN FRONT OF 13015 MCCRACKEN. IN THIS PROCESS, UNIT 1 WAS ALSO STRUCK ON DRIVER'S SIDE REAR. UNIIT 1 WAS STOPPED AND UNIT 2 WAS UP AGAINST THE REAR OR UNIT 1 UNIT 2 WHEELS WERE SPINNING DUE TO A POSSIBLE FAULTY ACCELERATER.
