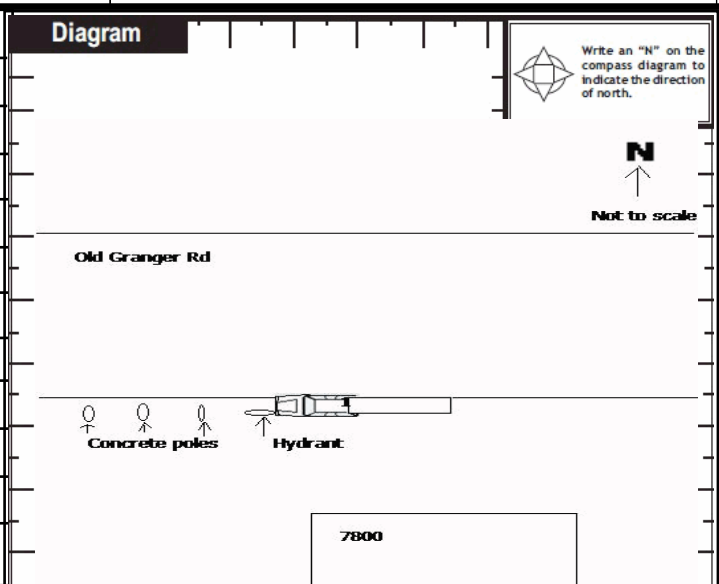

He stated the driver of the unknown semi then put his semi in gear and pulled out into his lane and hit his truck and pushed him in to the south lane and onto the curb at which time he hit a hydrant then a road sign and onto a cement pole. The unknown semi then left the area. The hydrant caused the street to flood and required the water dept to be contacted and the road to be closed. Once the the water was shut off officers inspected the truck and observed no damage anywhere consistent with the drivers story. Where unit one hit the hydrant a large sink hole was created.</p>
