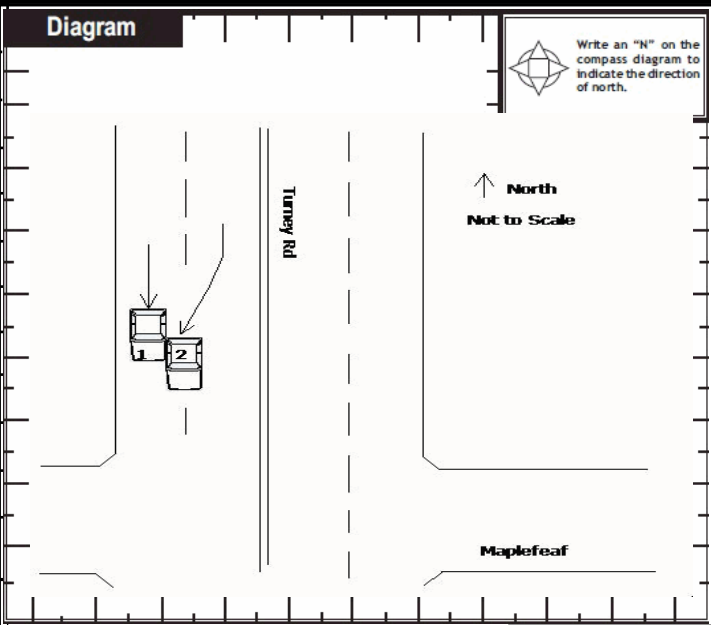

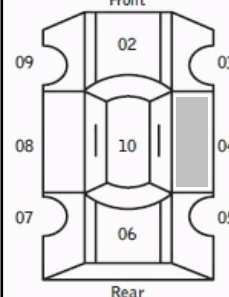
UNIT 1 WAS TRAVELING SOUTH ON TURNEY RD. IN THE CURB LANE APPROACHING MAPLELEAF DR. UNIT 2 WAS TRAVELING BESIDE UNIT 1 IN THE CENTER LANE. UNIT 2 ABRUPTLY SWITCHED FROM THE CENTER LANE TO THE CURB LANE WITHOUT YIELDING TO UNIT 1. UNIT 2 STRUCK UNIT 1 CAUSING DAMAGE. DRIVER OF UNIT 2 THEN LEFT THE AREA WITHOUT PROVIDING REQUIRED INFORMATION. HE WAS LATER POSITIVELY IDENTIFIED.

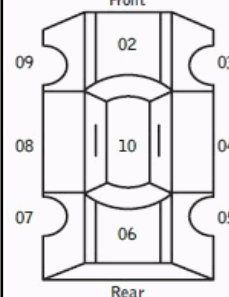
