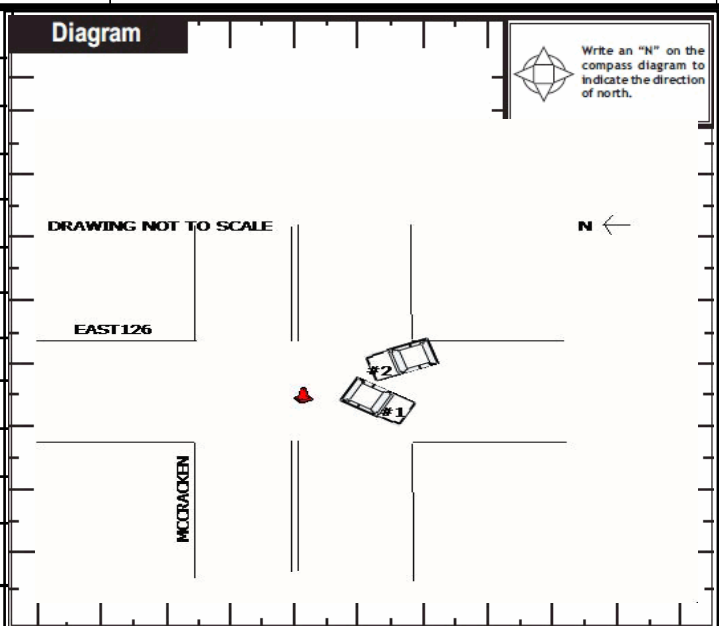





UNIT#2 THEN WENT THROUGH THE RED LIGHT AND WAS MAKING A LEFT TURN ON TO MCCRACKEN. UNIT#2 DID NOT YIELD TO UNIT#1 THAT WAS ALREADY MAKING THE TURN AND STRUCK UNIT#1 ON THE DRIVER SIDE REAR DOOR AND QUARTER PANNEL. UNIT#2 TOLD UNIT#1 THAT SHE WAS SORRY AND THEN LEFT THE SCENE.
