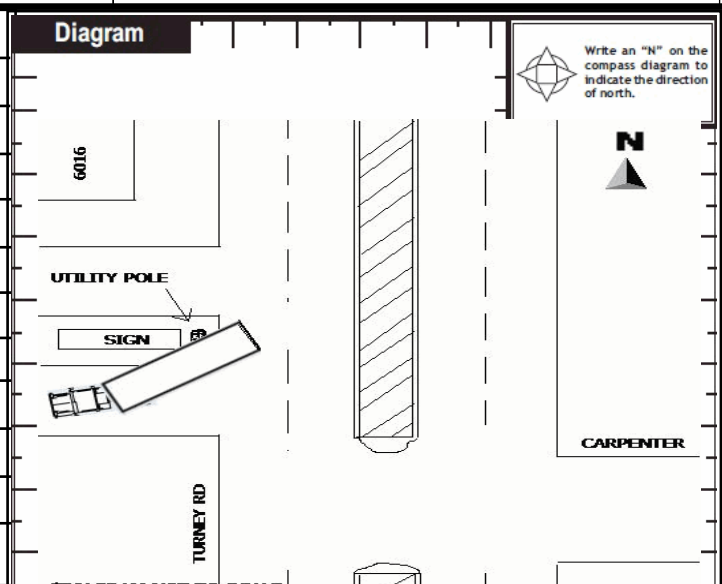

 UNIT 1 WAS TRAVELING S/B ON TURNEY IN THE RIGHT LANE APPROACHING THE DIVIDED DRIVEWAY TO 6016 TURNEY. UNIT 1 PASSED THE W/B INGRESS TO THE DRIVEWAY AND ATTEMPTED TO TURN RIGHT INTO THE EGRESS OF THE DRIVEWAY. UNIT 1 FAILED TO MAINTAIN CONTROL WHILE TURNING RIGHT CAUSING THE 53' CARGO TRAILER OF UNIT 1 TO STRIKE A UTILITY POLE (# 304246). AFTER STRIKING THE POLE UNIT 1 CONTINUED ITS RIGHT TURN AND STRUCK A LARGE BUSINESS SIGN. BUSINESS SIGN IS THE PROPERTY OF THE GLIMCHERGROUP. UTILITY POLE IS THE PROPERTY OF FIRST ENERGY.
