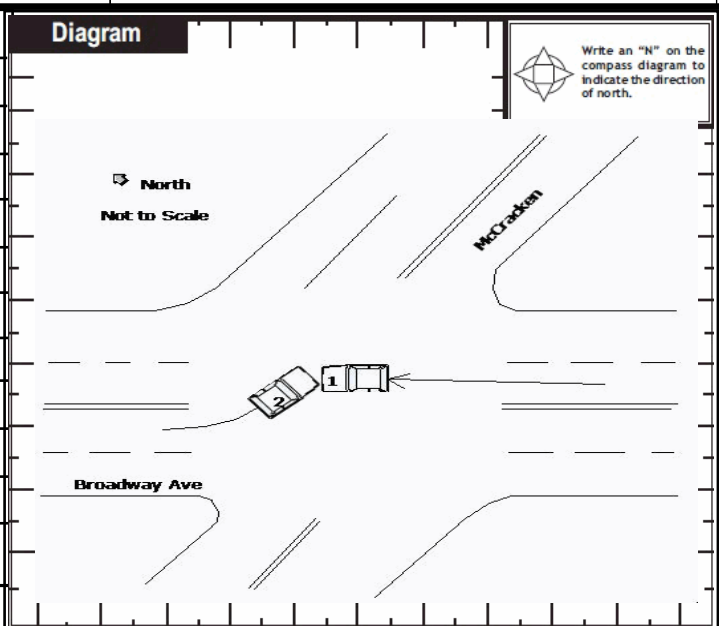

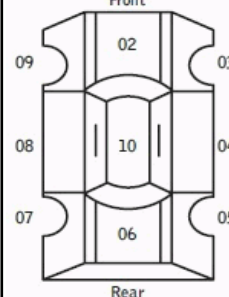
Narrative

UNIT 2 WAS TRAVELING WEST ON BROADWAY AVE. APPROACHING MCCRACKEN RD. UNIT 1 WAS TRAVELING EAST ON BROADWAY AVE. AND PREPARING TO TURN LEFT ONTO MCCRACKEN. UNIT 2 PROCEEDED STRAIGHT THROUGH THE INTERSECTION WITH MCCRACKEN UNDER A GREEN LIGHT. UNIT 1 FAILED TO YIELD TO UNIT 2 AND TURNED IN FRONT OF UNIT 2 CAUSING UNIT 2 TO STRIKE UNIT 1.
