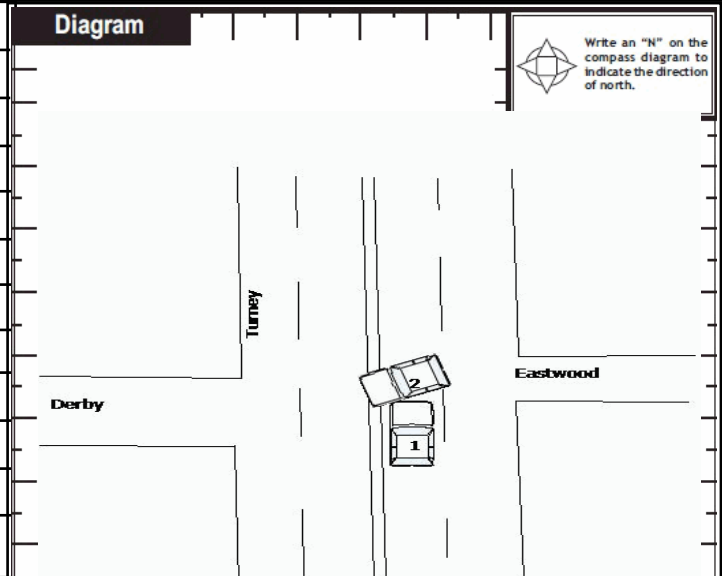

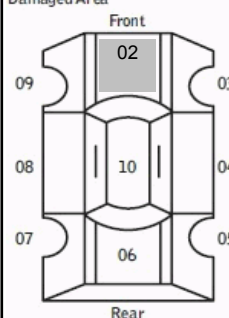



UNIT 2 THEN FLED THE AREA GOING BACK EASTBOUND ON OAKVIEW. ON 10/29/17 OFFICER KREJCI RESPONDED TO THE LISTED ADDRESSES FOR THE DRIVER AND THE OWNER OF THE STRUCK VEHICLE. BOTH PROPERTIES WERE VACANT.
