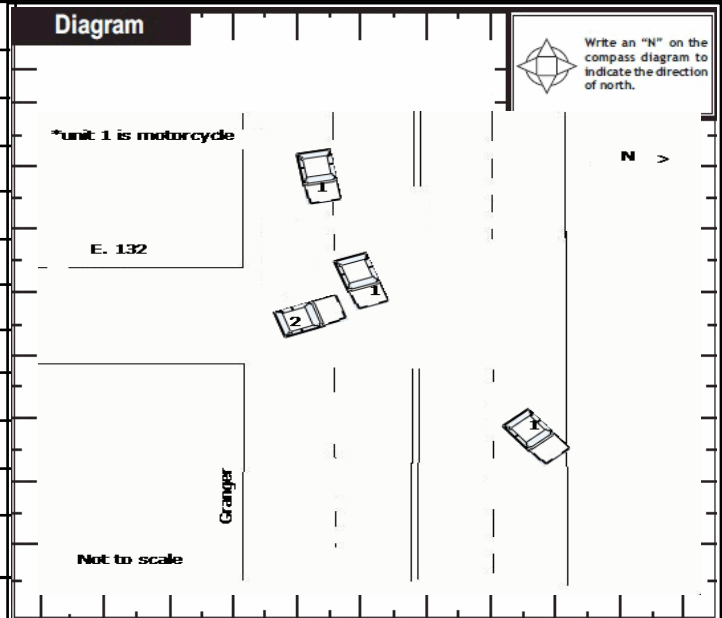



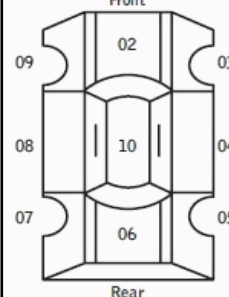

DRIVER OF UNIT1 APPLIED THE BRAKES CAUSING THE MOTORCYCLE TO SKID AND ULTIMATELY CAUSING HIM TO LOSE CONTROL OF UNIT 1. UNIT 1 THEN FELL ON TO ITS LEFT SIDE AND SLID ACROSS THE W.B LANES OF TRAVEL AND CAME TO REST ALONG THE NORTH CURB.
 DRIVER OF UNIT 2 STATES SHE DID NOT SEE UNIT 1 AND PULLED ONTO GRANGER, ONCE IN THE INTERSECTION SHE OBSERVED UNIT 1 AT WHICH TIME UNIT 1 BEGAN SKIDDING TO AVOID CONTACT. NO CONTACT WAS MADE
